district) of Saint James Wigan, all in the county | and diocese aforesaid, which said extremities lie contiguous one to another and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such

cures respectively.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of Pemberton of the said new parish of Saint Andrew Wigan, of the said parish of (All Saints) Wigan, of the said new parish of Saint Thomas Wigan, and of the new parish of Saint James Wigan aforesaid should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of Saint Mark Newtown Pemberton situate as aforesaid.

"Now therefore, with the consent of the Right Reverend John Charles Bishop of the said diocese of Liverpool, as such Bishop, with the consent of the Honourable and Reverend George Thomas Orlando Bridgeman the rector of the rectory of the said parish of (All Saints) Wigan, and as such rector, the patron of the vicarages of the said new parish of Pemberton, of the said new parish of Saint Andrew Wigan, and of the said new parish of Saint Thomas Wigan, respectively, with the consent of the Right Honourable Orlando George Charles, Earl of Bradford, the patron of the said parish of (All Saints) Wigan, and with the consent of Nathaniel Eckersley of Standish Hall near Wigan Esquire the patron of the said new parish of Saint James Wigan (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Pemberton, of the said new parish of Saint Andrew Wigan of the said parish of (All Saints) Wigan, of the said new parish of Saint Thomas Wigan, and of the said new parish of Saint James Wigan which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Mark Newtown Pemberton situate as aforesaid and that the same should be named 'The Consolidated Chapelry of Saint Mark, Newtown Pemberton.

"We therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mark Newtown Pemberton comprising :-

"All those several contiguous portions of the new parish (sometime district chapelry) of Pemberton of the new parish (sometime district) of Saint Andrew Wigan of the parish of (All Saints) Wigan of the new parish (sometime district chapelry) of Saint Thomas Wigan and of the new parish (sometime district) of Saint James Wigan, all in the county of Lancaster and in the diocese of Liverpool which are comprised within and are bounded by an imaginary line commencing at the point where the respective boundaries

the said parish of (All Saints) Wigan, and of the new parish of Saint James Wigan aforesaid all meet, which point is at the centre of the viaduct which carries the Liverpool Bury and Manchester line of the Lancashire and Yorkshire Railway over the high road leading from Wigan to Warrington and extending thence that is to say from the said point south-westward along the middle of the said line of railway for a distance. of fourteen chains or thereabouts to a point at Cromwell's Ditch upon the boundary which divides the said new parish of Saint James Wigan from the new parish of Pemberton aforesaid and extending thence first still south-westward and then southward along the last-mentioned boundary for a distance of sixty-one chains or thereabouts (thereby at first continuing to follow the middle of the said line of railway and then following the middle of the said high road leading from Wigan to Warrington) to the point near Smithy Brook where the same road is joined by Littlelane and extending thence first westward and then north-westward along the middle of the said lane for a distance of forty chains or thereabouts to its junction with Billinge-road and extending thence north-eastward along the middle of the lastnamed road for a distance of twenty chains or thereabouts to its junction with the road called or known as Spring Bank, and extending thence north-westward along the middle of the lastnamed road for a distance of fifteen chains or thereabouts to its junction with Ormskirk-road and extending thence first south-westward and then westward along the middle of the last-named road for a distance of thirty-seven chains or thereabouts to its junction with Thorburn-lane and extending thence generally northward along the middle of the last-named lane for a distance of seventy-five chains or thereabouts to the point, near Marsh Green, where the same lane is joined by the footpath which leads to the cottages called or known as Bankes's Houses and extending thence in a direction due north-west and in a straight line for a distance of ten chains or thereabouts to a point in the middle of the stream flowing from Orrell City past the north-western side of Marsh Green aforesaid into the River Douglas and extending thence north-eastward along the middle of the said stream for a distance of twenty-nine and a half chains or thereabouts to the centre of the bridge or culvert which carries Coal Pit-lane over the said stream and extending thence first northward and then westward along the middle of the last-named lane for a distance of fourteen chains or thereabouts to its junction with Walthew House-lane and with Markland Milllane and extending thence generally north-eastward: along the middle of the last-named lane for a distance of twenty-seven chains or thereabouts (thereby crossing the boundary which divides the said new parish of Pemberton from the new parish of Saint Andrew Wigan aforesaid) to the centre of the bridge which carries the same lane over the Leeds and Liverpool Canal and extending thence generally south-eastward along the middle of the said canal for a distance of fifty-eight chains or thereabouts to the boundary which divides the said new parish of Saint Andrew Wigan from the district chapelry of Saint Michael and All Angels Wigan, in the county and diocese aforesaid, and extending thence south-westward along the lastmentioned boundary for a distance of six and a half chains or thereabouts to the point at the confluence of Scots-lane Brook with the River Douglas where the same boundary meets the boundary which divides the said district chapelry of the said new parish of Saint Thomas Wigan of I of Saint Michael and All Angels Wigan from the
