THE Queen has been pleased to order a Congé d'Élire to pass the Great Seal of the United Kingdom of Great Britain and Ireland, empowering the Dean and Chapter of the Cathedral Church of Carlisle to elect a Bishop of that See, the same being void by the death of Doctor Harvey Goodwin, late Bishop thereof; and Her Majesty has been pleased to recommend to the said Dean and Chapter the Right Reverend Father in God Doctor John Wareing Bardsley, now Bishop of Sodor and Man, to be by them elected Bishop of the said See of Carlisle.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 14th January, 1892, from Her Majesty's Representative at Madrid, enclosing an extract from the Madrid Gazette, stating that, owing to information received by the Board of Health of the disappearance of cholera at Yokohama, the Order of the 19th December last, subjecting all arrivals in Spanish ports from that place to observation, has been annulled.
