THE following further Addresses and Resolutions of Condolence, on the occasion of the death of His Royal Highness Prince Albert Victor, Duke of Clarence and Avondale, K.G., &c., have been transmitted to the Right Honourable Henry Matthews, Her Majesty's Principal Secretary of State for the Home Department, for presentation to The Queen, and have accordingly been presented by him to Her Majesty, who has been pleased to · receive the same very graciously :--

London.

AT the General Quarter Session of the Peace of our Lady the Queen, holden in and for the county of London, at the Sessions House, Clerkenwell, for the said county, on Monday, the 4th day of January, in the 55th year of the Reign of our Sovereign Lady Victoria, by the Grace of God, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, and from thence continued by several adjournments to and holden at the said Sessions House, on Thursday, the 28th day of January, in the said 55th year of the Reign of our said Lady the Queen, and in the year of our Lord 1892, on the motion of Sir Peter Henry Edlin, Q.C., D.L., the Chairman of the Court, seconded by John Fish Pownall, Esq., it is unanimously resolved that the following Address of Condolence with Her Majesty on the lamented death of His Royal Highness Prince Albert Victor, Duke of Clarence and Avondale, K.G., be adopted :-

To the QUEEN's Most Excellent Majesty.

May it please Your Majesty, E, Your Majesty's Justices of the Peace for the County of London, in Quarter Sessions assembled, beg most respectfully to tender to Your Majesty the expression of our heartfelt grief and sorrow upon the death of Your Grandson His Royal Highness the Duke of Clarence and Avondale.

Your Majesty is aware that this tragic event has deeply stirred the hearts of Your People throughout the Empire, and that the desire has been universal to make known to Your Majesty the profound sympathy which has been felt for You in Your great affliction and in the unspeak-able bereavement which has fallen on Your Royal House.

Your Majesty's subjects have now the satisfaction of reading Your own tender and gracious assurance that this sympathy has been deeply gratifying to You. We rejoice most heartily that

it has thus affected Your Majesty, and in our sincere and loyal desire to condole with Your Majesty, we pray earnestly that You may live to experience the truest consolation possible in this dire bereavement, and that Your Majesty may be spared for many years to reign in the hearts of Your faithful and devoted subjects.
