THE following further Addresses and Resolutions of Condolence, on the occasion of the death of His Royal Highness Prince Albert Victor, Duke of Clarence and Avondale, K.G., &c., have been transmitted to the Right Honourable Henry Matthews, Her Majesty's Principal Secretary of State for the Home Department, for presentation to The Queen, and have accordingly been presented by him to Her Majesty, who has been pleased to receive the same very graciously:—

AT the Quarter Sessions of the Peace of our Lady the Queen, holden in and for the county of Middlesex, at the Sessions House, Broad Sanctuary, Westminster, for the said county, on Saturday, the 9th of January, in the 55th year of the Reign of our Sovereign Lady Victoria, by the Grace of God, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, and from thence continued by several adjournments to and holden at the said Sessions House, on Saturday, the 30th day of January, in the said 55th year of the Reign of our said Lady the Queen, and in the year of our Lord 1892, before R. D. M. Littler, Esq., C.B., Q.C., Chairman of the Court, R. Loveland-Loveland, Esq., Deputy-Chairman, and other Justices of the Peace for the said county, on the motion of the Chairman of the Court, seconded by the Deputy-Chairman, it is resolved unanimously:—that the following Address now read to the Court be adopted and be presented to the Queen's Most Excellent Majesty:—

To the QUEEN's Most Excellent Majesty.

May it please Your Majesty,

WE, Your Majesty's loyal and dutiful Justices of the Peace for the County of Middlesex, in Quarter Sessions assembled, beg most respectfully to tender the expression of our profound sorrow and very deep condolence with Your Majesty on the sudden and sad death of Your Grandson, His Royal Highness the Duke of Clarence and Avondale, K.G.

That His Royal Highness had gained for himself the esteem and affection of Your Majesty's subjects is manifestly shown by the expressions of widespread interest evoked by his hoped-for marriage, and the still more universal sympathy evinced for his untimely death by all classes of Your loyal subjects.

We pray that Your Majesty may be comforted in this sad and sudden bereavement by, these

expressions of attachment to you, and trust that Your Majesty may be spared for many years to live and reign over this great Empire.
