WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of two hundred pounds sterling, which has been paid to us in favour of the vicarage of Saint Stephen, Hull, in the county of York, and in the diocese of York, and in respect of which we have agreed to pay to the Incumbent of the same vicarage, and to his successors, a yearly sum of six pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant out of our common fund to the said vicarage of Saint Stephen, Hull, to meet such benefaction, one other capital sum of two hundred pounds, in respect of which, so long as the same capital sum or any part thereof shall remain in our hands, there shall be paid by us to the Incumbent for the time being of the said vicarage one other yearly sum of six pounds, or such part thereof as shall be proportionate to any balance of the same capital sum which shall so remain in our hands; such lastly-mentioned yearly payment to commence as from the date of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions on the first day of May and the first day of November in each and every year.

In witness whereof, we have hereunto set our common seal, this seventeenth day of March, in the year one thousand eight hundred and ninety-two.
