or liability accrued thereunder before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, any Order or part of any Order hereby revoked before the commencement of this Order.

The district or area described in the Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Zone, and shall be subject to the provisions of the Foot-and-Mouth Disease Order of 1892, No. 2, dated the sixth day of April, one thousand eight hundred and ninety-two, relating to Foot-and-Mouth Disease Infected Zones and of any Order amending the same.

2. This Order shall take effect from and immediately after this thirteenth day of April, one thousand eight hundred and ninety-two.

SCHEDULE.*Description of Infected Zone.*

A district or area in the county of Chester comprising all the parishes of the Poor Law Union of Altrincham, that is to say, the parishes of Agden, Altrincham, Ashley, Ashton-upon-Mersey, Aston-by-Budworth, Baguley, Bexton,

Rollin-Fee, Bollington, Bowden, Carrington, Dunham Massey, Etchells, Fulshaw, Hale, High Leigh, Lymm, Marhall-with-Little-Warford, Mere, Millington, Mobberley, Nether Knutsford, Northen, Ollerton, Over Knutsford, Partington, Peover Inferior, Peover Superior, Pickmere, Plumbly, Pownall-Fee, Rostherne, Sale, Tabley Inferior, Tabley Superior, Tatton, Timperley, Toft, and Warburton.

(FOOT-AND-MOUTH DISEASE INFECTED ZONE.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The district or area described in the Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Zone, and shall be subject to the provisions of the Foot-and-Mouth Disease Order of 1892, No. 2, dated the sixth day of April, one thousand eight hundred and ninety-two, relating to Foot-and-Mouth Disease Infected Zones and of any Order amending the same.

2. For the purposes of this Order and of the Foot-and-Mouth Disease Order of 1892, No. 2, animals shall not be deemed to be moved into, in, or out of the Infected Zone described in the Schedule to this Order, where having been landed at a Landing-place for foreign animals in the Infected Zone, they are moved by the most direct available route to the nearest available railway station (such station being within the Zone) on the line of railway by which the animals are to be moved to their place of destination, and are kept

at such railway station until trucked and are then moved by rail to the place of destination without unnecessary delay and without being untrucked or re-booked within the Infected Zone.

2. This Order shall take effect from and immediately after this thirteenth day of April, one thousand eight hundred and ninety-two.

A district or area in the county of Perth comprising the parishes of Aberdalgie, Arngask, Auchterarder, Blackford, Dron, Dunbarney, Dunning, Findogask, Forgandenny, Forteviot, Glendevon, Madderty, Muckhart, Tibbermore, and Trinity Gask.
