*Board of Trade (Harbour Department),
London, April 23, 1892.*

THE Board of Trade have received, through the Secretary of State for the Colonies, a copy of a Notice (No. 62), dated 11th April, 1892, issued by Her Majesty's Representative at Malta, whereby the following paragraph is substituted for paragraph 1 of the Notice issued on the 11th February, 1892 (No. 28), being itself a modification of the Notice issued on the 14th October, 1891 (No. 178):—

1. Vessels with pilgrims from the East, or having had cases of cholera on board, as well as all vessels having, or having had, on board cases of diarrhoea, which in the opinion of the quarantine medical officer may be presumed to indicate cholera, shall not be permitted to enter this harbour.

Vessels coming from Rio Janeiro or other ports, when cases of yellow fever have taken place on board, shall not be permitted to enter this harbour, except, if necessary, to coal in strict quarantine, and on condition that they leave afterwards with the least possible delay.

Vessels coming from ports known to be infected with yellow fever are to be subjected to fourteen days' quarantine, and to be disinfected, unless they have been disinfected at an intermediate port.

GENERAL ORDER of the Local Government Board: Altering General Consolidated Order: Allowance of Tobacco and Snuff to certain Paupers in the Workhouse:—

Cuckfield Union.

To the Guardians of the Poor of the Cuckfield Union, in the Counties of East Sussex and West Sussex;—

And to all others whom it may concern.

WHEREAS by a General Order dated the 24th day of July, 1847, addressed to the Guardians of the Poor of the said Cuckfield Union (amongst others), the Poor Law Commissioners made certain Rules and Regulations with regard to the government of the Workhouse of the said Union;

And whereas it is expedient that further provision should be made as hereinafter mentioned:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order that, from and after the date hereof, the following regulations shall be in force in the said Cuckfield Union, namely,—

ARTICLE I.—Tobacco or snuff may be allowed to such of the inmates of the Workhouse of the Union who are not able-bodied, or are employed upon work of a specially disagreeable character, as the Guardians may consider should be supplied with the same, the quantity to be allowed in each case, or in any class of cases, to be such as the Guardians may by resolution prescribe.

ARTICLE II.—So much of Article 121 of the said General Order as provides that no pauper shall smoke in any room in the Workhouse except by the special direction of the Medical Officer shall be rescinded, so far as regards the said Union; but the Guardians may from time to time, by resolution, determine in what rooms and at what times smoking shall be allowed, and no pauper shall smoke in the Workhouse in any other room or at any other time than is so allowed.
