Affairs has been informed by the French Ambassador at the Court of St. James's that, with a view to prevent the importation of arms and munitions of war into Dahomey, the Government of the Republic has determined to establish, from the 15th instant, a Blockade of the portion of the Slave Coast comprised between the limit of the French and German possessious of the Popos (6° 14' 15" of north latitude, and 0° 40' 36" of longitude west of Paris), and the eastern limit of the French possessions of Porto Novo, which, according to the arrangement between England and France of the 10th August, 1889, is fixed on the coast by the line of the meridian passing through Ajarra Creek.
