THE Board of Agriculture, acting under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, hereby authorize the Local Authority for the Parts of Lindsey, Lincolnshire, to put in operation Article 1 of the Swine-Fever Order of 1890, dated the fourteenth day of March, one thousand eight hundred and ninety, providing for the slaughter by Local Authorities of swine suspected of swine-fever, and the payment of compensation for the same.

This Authority shall cease to operate from and immediately after the twenty-first day of September, one thousand eight hundred and ninety-two, unless previously revoked by the Board of Agriculture.

In witness whereof the Board of Agriculture have hereunto set their Official Seal this twenty-first day of June, one thousand eight hundred and ninety-two.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, and with reference especially to Article 96 of the Animals Order of 1886, do hereby license the Local Authority for the borough of St. Helens to dig up or cause to be dug up, within fourteen days after the date of this Licence, the carcasses of two pigs belonging to James Leicester which recently died and were buried; subject to the following conditions:—

1 When dug up the Local Authority shall forthwith cause the carcasses to be examined with a view to ascertain whether the animals were affected with contagious or infectious disease, and the Local Authority shall then cause the carcasses to be re-buried as soon as possible, and shall cause them to be covered with a sufficient quantity of quick lime or other disinfectant, and with not less than six feet of earth.
