"1. Eleven days' quarantine, to be performed at Delos, on arrivals from Russian Black Sea ports, from Batoum inclusive to Soukoum Kale inclusive, having sailed since 29th June, if they have passed Bosphorus without performing Turkish ten days' quarantine.

"2. Five days' observation at any health office on arrivals from Black Sea ports from Soukoum Kale, exclusive, to Kustendje, inclusive, under same conditions.

"3. Medical inspection of arrivals from Beyrout, inclusive, to Jaffa, exclusive, having sailed since 2nd July."

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 4th July, 1892, from Her Majesty's Representative at Vienna, enclosing the following Circular relative to Quarantine :-

In consequence of Cholera having broken out in Southern Russia, arrivals from Russian Ports in the Black Sea and in the Sea of Azov will be subjected to a quarantine observation of seven days.

Wearing apparel will be disinfected according to the usual method.

Arrivals from Turkish Ports of the Black Sea will undergo a strict medical visit.

Such treatment applies if the vessel has had a good passage and arrives in perfectly healthy conditions; in any other case the facts are to be reported without loss of time to the Imperial and Royal Marine Board.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Telegrams, dated 10th July, 1892, from Her Majesty's Representatives at Madrid, Sofia, and Bucharest, relating to quarantine :

Madrid :- In consequence of cases of cholera in South Russia, ten days' quarantine is imposed on arrivals therefrom where no case has occurred on board, fifteen days in contrary case.

Copy of Telegram from Her Majesty's Agent

and Consul-General, Sofia, July 10. My Telegram of July 3. Ships arriving from Russian ports in Black Sea and Sea of Azov, and from Turkish ports from Trebizond to Batoum are excluded from all Bulgarian ports, except Bourgas and Varna, where they will be kept in quarantine eleven days. Ships arriving from Russian and Roumanian ports on Danube and Roumanian Black Sea ports will undergo five days' quarantine, as also passengers from Dobrudja frontier.

Copy of Telegram from Her Majesty's Chargé d'Affaires, Bucharest, July 10 :-

My Telegram of the 7th instant. Supplementary Quarantine Regulations, section 1, extended to arrivals from whole coast of Asiatic Turkey. 2. Five days' quarantine for arrivals from other Russian Black Sea ports, and from those on coast of Asiatic Turkey. Kustendje open only to Fraissinet and Lloyd mails which have undergone quarantine at Constantinople but not touched at a Russian or other Black Sea port.
