British Vice-Consulate,

Bourgas, July 5, 1892.

I have to inform you that a further telegram has been received from Constantinople at the International Health Office here, stating that, dating from the 2nd instant, five days' quarantine will be imposed on all vessels coming from all Russian and Roumanian Ports whatsoever, whether on the Black Sea Coast or up the Danube from Soukhoum Kalé (not included) right round to the Bulgárian Frontier, as well as on all vessels coming from the Turkish Ports which lie between the Trans-Caucasian Frontier and Trebizond (not included).

A quarantine of ten days will continue to be imposed on arrivals from the Trans-Caucasus, while vessels hailing from other Turkish Ports in the Black Sea will still be subjected to medical inspection on their arrival at Cavak.

Government Notice .-- No. 105.

HIS Excellency the Governor, having heard the opinion of the Board of Health, has been pleased to direct that Government Notice, No. 62, of the 11th April, 1892, is to be modified with reference to paragraph 4, and that the other provisions therein as to quarantine and medical inspection remaining in force, the following regulations are to be observed, viz. :-

1. Vessels with pilgrims from the East, or having had cases of cholera on board, as well as all vessels having, or having had, on board cases of diarrhœa, which in the opinion of the Quarantine Medical Officer may be presumed to indicate cholera, shall not be permitted to enter this harbour.

Vessels coming from Rio Janeiro or other ports, when cases of yellow fever have taken place on board, shall not be permitted to enter this harbour, except, if necessary, to coal in strict quarantine, and on condition that they leave afterwards with the least possible delay.

Vessels coming from ports known to be infected with yellow fever are to be subjected to 14 days' quarantine and to be disinfected, unless they have been disinfected at an intermediate port.

2. Vessels not provided with duly authorized medical officers shall undergo strict medical inspection on arrival from any ports of Southern Europe (from Cape St. Vincent eastwards), of Turkey in Asia, and of Northern Africa east of Tangiers.

4. Vessels not provided with a qualified medical officer, arriving direct from Adalia and Jaffa and from the coast of Turkey in Asia between those ports, are to undergo seven days' quarantine.
