Hugh St. Leger, Esquire, Ethel St. Leger, Edith St. Leger, and Ursule St. Leger, Spinsters, the brothers and sisters of the said Edward, Viscount Doneraile, shall henceforth have, hold, and enjoy the title, rank, place, preeminence, and precedence as younger children of a Viscount, to which honour they would have been entitled had their father succeeded to the dignity of Viscount Doneraile :
