of a Notice issued by the German Government, intimating that all arrivals from the Black Sea, or from Russian Baltic ports, are to be subjected to a strict medical supervision.

London, August 2, 1892. THE Board of Trade have received. through the Secretary of State for Foreign Affairs, the following Telegram from Her Majesty's Repre-sentative at Constantinople, viz.:---"Arrivals from coast between Kertch and Ordu, inclusive, will undergo ten days' quarantine at Sinope. Arrivals from the Black Sea from Kertch to Roumanian frontier will go to Karak. Ships with cholera on board will proceed to Sinope."

(H. 5845.) Board of Trade (Harbour Department), London, August 2, 1892.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following Telegram from Her Majesty's Representative at Athens, viz. :-- " Eleven days' quarantine imposed on arrivals from Black Sea ports, between Batoum and Ordou. Eleven days' quarantine against Beyrout abclished, but maintained for ports between Beyrout and Jaffa, exclusive."

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, from Her Majesty's Representative at Lisbon, enclosing the following Quarantine Notice, issued by the Portuguese Government, viz.:

Maritime Sanitary Notice .- No. 501.

In view of the official reports received and of the opinion of the Consultative Board of Public Health, the importation by sea of uncleansed wool from France, whether coming directly from any French port or from a port of any other nation, is prohibited; and as regards any washed wool, it will have to undergo a proper disinfection at the Lazaretto.
