

of Saint Mary Stoke Newington of the said new parish of Saint Andrew Stoke Newington of the said new parish of Saint John Vartry-road Stamford Hill and of the said new parish of Saint Ann Hanger-lane which are described in the schedule hereunder written (all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed) shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Saint Olave Stoke Newington' and that the said district so soon as a minister shall have been licensed thereto shall be endowed as contemplated by the aforesaid Order of Your Majesty in Council.

"And we further recommend and propose that the whole right of patronage of the said proposed district and (so soon as the said district shall have become a new parish as aforesaid then) of the said new parish and of the nomination of the minister of the said proposed district or (as the case may be) of the incumbent of the said new parish shall (as is provided by the hereinbefore-recited Order in Council) be assigned to and be absolutely vested in Your Majesty and be exercised by the said Lord Chancellor acting on behalf of the Crown and his successors for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or to any of them in accordance with the provisions of the said Act or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The district of Saint Olave Stoke Newington, comprising:

"All those several contiguous portions of the parish of Saint Mary Stoke Newington of the new parish (sometime district) of Saint Andrew Stoke Newington, of the new parish (sometime district chapelry) of Saint John Vartry-road, Stamford Hill and of the new parish (sometime particular district) of Saint Ann Hanger-lane all in the county of Middlesex and in the diocese of London all which portions are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said new parish of Saint Andrew Stoke Newington from the parish of Saint Mary Stoke Newington aforesaid at the point where Lordship-road is joined by the road called or known as Queen Elizabeth's-walk and extending thence south-westward along the middle of the last-named road for a distance of thirteen chains or thereabouts to its junction with Allerton-road and continuing thence first south-westward and then southward along the middle of the last-named road for a distance of sixteen and a half chains or thereabouts to its junction with the road called or known as Lordship Park and extending thence south-westward along the middle of the last-named road for a distance of five chains or thereabouts to a point at its junction with the road called or known as Green-lanes and with Brown-wood-road upon the boundary on the western side of the said Green-lanes which boundary divides the said parish of Saint Mary Stoke Newington from the new parish of Saint John the Evangelist Brown-wood Park in the county and diocese aforesaid and extending thence north-westward along the last-mentioned boundary for a distance of forty chains or thereabouts thereby following the western side

of the road called or known as Green-lanes aforesaid to a point at its junction with Seven Sisters-road where the boundary which divides the said new parish of Saint John the Evangelist, Brown-wood Park from that portion of the parish of Hornsey in the county and diocese aforesaid (comprising generally the area of Finsbury Park) wherein the present incumbent of such parish still possesses the exclusive cure of souls but which for all ecclesiastical purposes is an isolated part of that parish is joined by the boundary which divides the said isolated portion of the parish of Hornsey from the parish of Saint Mary Stoke Newington aforesaid and extending thence north-westward along the last-mentioned boundary for a distance of seventeen and a half chains or thereabouts, thereby continuing to follow the western side of the said road called or known as Green-lanes, to the point a little to the west of the bridge which carries the last-named road over the New River aforesaid where the said last-mentioned boundary joins the boundary dividing the said isolated portion of the parish of Hornsey from the new parish of Saint John Vartry-road Stamford Hill aforesaid and continuing thence still north-westward along the last-mentioned boundary for a distance of six chains or thereabouts, thereby continuing to follow the western side of the said last-named road, to the point where such boundary diverges from the said road and extending thence first eastward to and then north-westward along the middle of the same road for a distance of fourteen chains or thereabouts, (thereby crossing, at the junction of the same road with Hermitage-road, the boundary which divides the said new parish of Saint John Vartry-road, Stamford Hill from the new parish of Saint Ann Hanger-lane aforesaid) to the centre of the bridge which carries the line of the Tottenham and Hampstead Junction Railway over the last-named road, the said bridge being at the entrance to the Harringay Park Railway Station and extending thence north-eastward along the middle of the said line of railway for a distance of twenty-eight chains or thereabouts, thereby passing through the said railway station, to a point at the centre of the second bridge under the same line of railway to the east of the said railway station and extending thence in a direction due south and in a straight line for a distance of twenty-three chains (thereby crossing at Hermitage-road the boundary which divides the said new parish of Saint Ann Hanger-lane from the new parish of Saint John Vartry-road Stamford Hill aforesaid) to a point in the middle of Eade-road, and extending thence eastward along the middle of the last-named road for a distance of eighteen chains or thereabouts to its junction with the Seven Sisters-road aforesaid and extending thence south-westward along the middle of the last-named road for a distance of twenty chains or thereabouts (thereby following as between the road called Amburst Park and the Seven Sisters Bridge over the New River aforesaid, the boundary which divides the said new parish of Saint John Vartry-road Stamford Hill from the new parish of Saint Andrew Stoke Newington aforesaid) to a point at the junction of the said Seven Sisters-road with Lordship-road aforesaid upon the boundary which divides the said new parish of Saint Andrew Stoke Newington from the parish of Saint Mary Stoke Newington aforesaid and extending thence south-eastward along the middle of the last-named road for a distance of fifteen chains or thereabouts (thereby following the last-described boundary and passing between the two reservoirs belonging to the New River Water Company) to the first-
