THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 11th August, 1892, from Her Majesty's Representative at Bucharest, enclosing a summary of a Decree issued by the Roumanian Government, relative to quarantine. The following Translation is a résumé of the same:—

The notice prohibits the importation into Roumania from Russia, or any country in which cholera should ultimately break out, of the following articles:—

(a.) Used bed and body linen, unwashed, introduced as article of commerce.

(b.) Worn clothes, rags for paper making, and scraps of stuffs of all sorts and of paper.

(c.) Fur and goods of fur, skins, and leathers of all kinds and under all forms.

(d.) Felts, wool (washed or not), ox-hair, horse-hair, pig-bristles, camel-hair, feathers, downs, and cottons.

(e.) Bladders and guts (fresh, dry, or salted).

(f.) Caviar, fish, dried, smoked, salted, or prepared with oil, and fresh butter.

(g.) Specimens of merchandise.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 17th August, 1892, from Her Majesty's Representative at Copenhagen, enclosing a summary of a Decree issued by the Danish Government, relative to quarantine. The following Translation is a résumé of the same:—

By this notice the Regulations of Ch. 2 I of the Law of the 2nd July, 1880, concerning preventive measures against the introduction of contagious diseases, are put in force, until further orders, with respect to vessels coming from Russian ports of the Baltic, or having communicated with these ports, or during their voyage with other ships sailing from these ports.
