THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated 27th August, 1892, from Her Majesty's Representative at San Sebastian, stating that a Royal Order of this date has been published, prohibiting the import of rags, clothes, bedding, fruit, and vegetables, arriving from British India, Sea of Azov, Black Sea, Baltic Sea, Mediterranean coast of Asiatic Turkey, Gulf of Finland, Belgium, and France. Passengers' luggage and crews' effects to be fumigated and disinfected.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 22nd August, 1892, from Her Majesty's Representative at San Sebastian, enclosing the following Translation of a Circular relating to quarantine:—

Ministry of the Interior.

According to official notices received at this office, Asiatic cholera morbus has broken out in Wiborg (Gulf of Finland).

Arrivals from the said place are therefore subjected to the quarantine imposed by Article 35 of the Law of Health (Ley de Sanidad), viz.:—

Ten days' quarantine if no case has occurred on board, and fifteen days in any other case.

If after the 19th instant, any bill of health issued in the port of Wiborg, countersigned by our Consul as clean, is presented, the directors of the Health Office will prevent communication with the vessel, and report to this office.

In a similar manner, if, after the 15th of this month, any vessel arrives from St. Petersburg with a clean bill of health, bearing Consular visa signed by our Consul to that effect, communication with it will be prevented, the matter being reported to this central office.
