PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act passed in the Session of Parliament held in the twentieth and twenty-first years of Her Majesty's reign, intituled "An Act to amend the Burial Acts," it is, amongst other things, enacted, that it shall be lawful for Her Majesty, upon the representation of one of Her Majesty's Principal Secretaries of State, by and with the advice of Her Privy Council, from time to time to order such acts to be done by or under the directions of the churchwardens or such other persons as may have the care of any vaults or places of buria!, for preventing them from becoming or continuing dangerous or injurious to the public health; and that every such Order in Council shall be published in the London Gazette, and that such churchwardens or other persons shall do or cause to be done all acts ordered as aforesaid, and the expenses incurred in and about the doing thereof shall be paid out of the poor rates of the parish: Provided always, that no such representation shall be made until ten days' previous notice of the intention to make such representation should have been given to the churchwardens or other persons, or one of the churchwardens or other persons, having the care of the vaults or places of burial to which the representation relates:

And whereas one of Her Majesty's Principal Secretaries of State, after ten days' previous notice of his intention to make such representation had been duly given to the churchwardens of the parish of Saint Mary Woolnoth in the city of London, has made a representation, stating that he is of opinion that for the purpose of preventing the vaults and places of burial under and adjacent to the church of the said parish from becoming or continuing dangerous or injurious to the public health, an Order in Council should be made for the adoption of the measures hereinafter set forth:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that the said churchwardens or such other person or persons as may have the care of the vaults and places of burial under and adjacent to the said church, do adopt, or cause to be adopted, the following measures,

That all human remains found beneath the floor

of the parish church of Saint Mary Woolnoth, in the city of London, shall be removed and forthwith re-buried in some consecrated burial ground in which interments can legally be made; and that immediately below the proposed new floor a solid layer of hard concrete, at least two feet in thickness, the top being grouted in neat cement, shall be laid.

The whole work to be carried out under the supervision and to the satisfaction of the Medical Officer of Health for the city of London.

WHEREAS by an Act passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the burial "of the dead in England beyond the limits of the "Metropolis, and to amend the Act concerning "the burial of the dead in the Metropolis," it is enacted that, in case it appears to Her Majesty in Council, upon the representation of one of Her Majesty's Principal Secretaries of State, that, for the protection of the public health, the opening of any new burial-ground in any city or town, or within any other limits, save with the previous approval of one of such Secretaries of State, should be prohibited, or that burials in any city or town, or within any other limits, or in any burial-grounds or places of burial, should be wholly discontinued, or should be discontinued subject to any exception or qualification, it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, to order that no new burial-ground shall be opened in any city or town, or within such limits, without such previous approval, or (as the case may require) that, after a time mentioned in the Order, burials in such city or town, or within such limits, or in such burial-grounds or places of burial, shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and so from time to time as circumstances may require; provided always, that notice of such representation, and of the time when it shall please Her Majesty to order that the same be taken into consideration by the Privy Council, shall be published in the London Gazette, and shall be affixed on the doors of the churches

or chapels of, or on some other conspicuous places within, the parishes affected by such representation, one month before such representation is so considered; provided also, that no such representation shall be made in relation to the burialground of any parish until ten days' previous notice of the intention to make such representation shall have been given to the Incumbent and Vestry Clerk or Churchwardens of such parish:

And whereas by another Act passed in the session of Parliament held in the eightcenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the laws concerning "the burial of the dead in England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit:

And whereas one of Her Majesty's Principal Secretaries of State, after giving to the Incumbent and the Churchwardens of the parish hereinafter mentioned ten days' previous notice of his inten-tion to make such representation, has made a representation stating that he is of opinion that the Order of Her Majesty in Council of the thirty-first day of March, one thousand eight hundred and fifty-five, in so far as it affects burials in Attleborough Church and Churchyard, in the parish of Nuneaton, in the county of Warwick, should be varied, by substituting the following directions for those contained in the said Order in regard to burials in the said church and churchyard :-

That burials be discontinued forthwith and entirely in Attleborough church, in the parish of Nuneaton, in the county of Warwick, and also in the churchyard after the thirty-first December, one thousand eight hundred and ninety-two, except as follows:—
(a.) In such vaults and wholly walled

graves as are now existing in the churchyard, burials may be allowed on condition that every coffin buried therein be separately enclosed by stonework or brickwork properly

(b.) In such partly walled graves now existing in the churchyard as can be opened to the depth of five feet without exposing coffins or disturbing human remains burials may be allowed of so many of the relations of those interred therein at the date of the Order as can be buried at or below that depth.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council on the fourteenth day of October next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation, one month before the said fourteenth day of October.

The QUEEN's Most Excellent Majesty in Council.

HEREAS one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned ten days' previous notice of his intention to make such representation, has, under the provisions of an Act passed in the Session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning "the burial of the dead in England beyond the " limits of the Metropolis, and to amend the Act " concerning the burial of the dead in the " Metropolis," made a representation stating that, for the protection of the public health, no new burial ground should be opened in the undermentioned parishes without the previous approval of one of Her Majesty's Principal Secretaries of State, and that burials should be discontinued therein with the following modifications, viz.:-

DOLBENMAEN. - Forthwith and entirely in the parish church of Dolbenmaen in the county of Carnarvon and also in the churchyard

within twelve yards of the rectory.

FARNDON.—Forthwith and entirely in the parish church of Farndon, in the county of Nottingham, and also in the churchyard after the thirtieth June one thousand eight hundred and ninety-three, except as follows :-

In such earthen graves now existing in the churchyard as can be opened to the depth of five feet without exposing coffins or disturbing human remains, burials may be allowed of so many of the following relations of those interred therein at the date of the Order, viz. :-widows and widowers as can be buried at or below that depth.

FLETTON. - Forthwith and entirely in the parish church of Fletton in the county of Huntingdon, and also in the parts of the churchyard which lie within two yards of its western boundary and within thirty yards of the rectory.

BERKHAMPSTED .- Forthwith and entirely in Northchurch Baptist chapel, in the parish of Berkhampsted in the county of Herts, and also in the chapelyard within ten yards of any dwelling; and that in the rest of the chapelyard the following regulations should be obeved :-

1. No body shall be buried in any vault or walled grave unless the coffin be separately entombed in an airtight manner, that is, by properly cemented stone or brickwork which shall never be disturbed.

2. No carthen grave shall be dug within

one foot of any other grave.

3. No coffin shall be buried in any unwalled grave within four feet of the ordinary level of the ground unless it contains the body of a child under twelve years when it shall not be less than three feet below that level.

KINGSBURY EPISCOPI.—Forthwith and entirely in the parish church of Kingsbury Episcopi, in the county of Somerset; and also in the churchyard after the thirty-first October, one thousand eight hundred and ninety-two, except as follows:-

(a.) In such vaults and wholly walled graves as are now existing in the churchyard, burials may be allowed on condition that every coffin buried therein be separately enclosed by stonework or brickwork properly

(b.) In such partly walled graves as are now existing in the churchyard, provided that the earth above them can be opened to the depth of five feet without exposing coffins or disturbing human remains burials may be allowed of so many of the relations of those interred therein at the date of the Order as can be buried at or below that depth.

Forthwith and entirely in the Wesleyan chapel, in the parish of Kingsbury Episcopi, in the county of Somerset, and also in the

chapelyard except as follows:-

In such wholly walled graves as are now existing in the chapelyard, burials may be allowed on condition that every coffin buried therein be separately enclosed by stonework or brickwork properly cemented.

EARLS BARTON.—Forthwith and entirely in the Baptist chapel in the parish of Earls Barton, in the county of Northampton; and also in the chapelyard except as follows:-

In such earthen graves now existing in the chapelyard as can be opened to the depth of five feet without exposing coffins or disturbing human remains burials may be allowed of so many of the relations of those interred therein at the date of the Order as can be buried at or below that depth.

HERTFORD.-Forthwith and JOHN entirely in the Roman Catholic Chapel in the parish of Saint John Hertford, in the county of Hertford; and also in the chapel-

yard except as follows :-

In such earthen graves now existing in the chapelyard, as can be opened to the depth of five feet without exposing coffins or disturbing human remains, burials may be allowed of so many of the following relations of those interred therein at the date of the Order, viz.: widows and widowers as can be buried at or below that depth.

RENNINGTON.—Forthwith and entirely in the parish church of Rennington (Embleton) in the county of Northumberland; and also in the old part of the churchyard except as

follows:

In such reserved grave spaces (which when cpened are free from water) burials may be allowed of so many of the following relations of those interred therein at the date of the Order, viz.: widows and widowers, as can be buried at or below the depth of five feet.

RINGSTEAD.—Forthwith and entirely in the parish church of Ringstead in the county of Northampton; and also in the churchyard after the thirtieth of April, one thousand eight hundred and ninety-three except as

follows:

In such partly walled graves as are now existing in the churchyard, provided that the earth above them can be opened to the depth of five feet without exposing coffins or disturbing human remains, burials may be allowed of so many of the relations of those interred therein at the date of the Order as can be buried at or below that depth.

THURMASTON.-Forthwith and entirely in the parish church of Thurmaston in the county of Leicester; and also in the churchyard

except as follows :-

(a.) In such vaults and wholly walled graves as are now existing in the churchyard burials may be allowed on condition that every coffin buried therein be separately enclosed by stonework or brickwork properly cemented.

(b.) In such earthen graves now existing I

in the churchyard, as can be opened to the depth of five feet without exposing coffins or disturbing human remains, burials may be allowed of so many of the relations of those interred therein at the date of the Order as can be buried at or below that depth.

(c.) In such reserved grave spaces (limited to twelve in number) as have never before been buried in, and which when opened are free from water, burials may be allowed of so many members of the families to whom they may be allotted as can be buried at or below

the depth of five feet.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council on the

fourteenth day of October next:

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within the parishes affected by such representation one month before the said fourteenth day of October.

Quarantine has been established with regard to vessels coming from ports of the Elbe, or having communicated with the above ports, or, during their voyage, with ships coming from the above ports.

At the same time the importation from the above ports of the following articles is pro-

hibited :

1. Used linen, used wearing apparel and bedclothes, unless they form part of travellers' lug-In the latter case they will be disinfected under the supervision of the Authorities.

If bed linen and woollen garments, forming part of travellers' luggage, are found in an unwashed state, and are not at once sent back, the Authorities may take steps to have them burned.

Horses and skins.

The importation of the following articles from the German Empire, from France, and from Belgian ports is prohibited:

Rags, used wadding, wool-flock, paper-scrapings, fruit, vegetables, and flowers; and in the case of

Belgium, horses and skins.

The regulations of chapter 2 I of the Law of 2nd July, 1880, have been put in force as regards ships coming from-

(a) German ports between Warnemunde, inclusive, and Danish frontier, or from German ports on the North Sea between the Danish and the Netherlands frontiers;

(b.) French ports of the Atlantic or Channel;(c.) Belgian ports;—

or having communicated with these ports, or, during their voyage, with vessels coming from these ports.

The regulations as to the introduction of linen, &c., are the same as for ports of the Elbe (see

above).

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 28th August, 1892, from Her Majesty's Representative at The Hague, enclosing an extract from the Law of 23rd March, 1877.

The following is a translation of the same

Captains of ships arriving by sea, on board of which there is anyone attacked by an epidemic disorder, or on board of which, during fourteen days previous, any person has been attacked or has died of one of these maladies, are obliged, before entering a port or a commune of the kingdom, to give notice thereof to the Burgomaster, to cast anchor, and to remain in the place indicated by the Burgomaster, and to abstain from all communication with land, or with other ships until the ship has been disinfected in conformity with Article 25 of the Law of the 4th December, 1872. No one will be allowed to leave the ship or to board it, with the exception of the Pilot, the doctors whose duty it is to examine the ship, the persons charged with disinfecting it, the doctors or ecclesiastics visiting the sick, the

Custom House Officers in the exercise of their functions, and the officers of justice or police when their presence on board is required.

No goods or any object can be discharged or brought on board, with the exception of those intended for victualling the ship or the treatment of the sick persons.

Persons engaged in the transport of such articles are not allowed to board the vessel.

The clothing of all persons obliged, as above stated, to board the vessel, are disinfected immediately after they have left the vessel.

Persons who board the vessel in defiance of the above-mentioned prohibition will be considered as forming part of the crew, and subjected to the same regulations as the crew. They will, in in addition, become liable to the penalties imposed by the law for such offences against it.

THE Board of Trude have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 30th August, 1892, from Her Majesty's Representative at The Hague, reporting that a Notice has been published in the Official Gazette of that date, stating that as according to official information received cases of cholera with symptoms of Asiatic cholera have occurred at Havre, all places situated on the northern coast of France from the frontier of Belgium as far as including Brest, as well as all places in France situated on waters flowing into the Channel, are declared infected with Asiatic cholera. A second notice in the same Gazette states, that from the 2nd of September the introduction and transit of rags, articles of clothing that have been worn, unwashed bed linen from Germany, Belgium, and France is forbidden, travellers' luggage being included in this prohibition only as regards unwashed linen and sheets, which can only be brought into the country or taken through it after having been cleansed and disinfected in the manner prescribed by the Government Sanitary Inspector.

Duration of quarantine to be the same as that established at Gibraltar. Ships' passengers and merchandize from any other suspected ports must undergo Gibraltar. sanitary inspection and disinfection at Tangier before being admitted to any port in Morocco.

To all Port Sanitary Authorities ;-

To all Masters of Ships;—
And to all others whom it may concern.

WHEREAS We, the Local Government Board, are empowered by Section 130 of the Public Health Act, 1875, and Section 2 of the Public Health Act, 1889, from time to time to make, alter, and revoke such Regulations as to Us may seem fit, with a view to the treatment of persons affected with Cholera, and preventing the spread of Cholera, as well on the seas, rivers, and waters of the United Kingdom, and on the high seas within three miles of the coast thereof, as on land, and may declare by what Authority or Authorities such Regulations shall be enforced and executed:

Now therefore, We, the Local Government Board, do by this Our Order, and in exercise of the power conferred on us by the Public Health Act, 1875, the Public Health Act, 1889, and every other power enabling Us in that behalf,

make the following Regulations:—
ARTICLE I.—If the Medical Officer of Health have reason to believe that any ship coming or within the jurisdiction of the Sanitary Authority is infected with cholera, or has come from a place infected with cholera, he may direct the bilge water to be pumped out before such ship enters any Dock or Basin; and on the Sanitary Authority providing a proper supply of water for drinking and cooking purposes for persons on board the ship, he may direct all casks or tanks on board the ship containing water for the use of such persons to be emptied, and the Master shall cause the said directions to be carried into effect.

ARTICLE II.—This Order shall be read as one with Our Order dated the twenty-eighth day of August, one thousand eight hundred and ninety, and words herein shall have the same meaning as words in that Order.
