otherwise Wensum Ward shall comprise so much of the area of the city of Norwich as is contained within a line commencing from a point in the boundary of Ward No. 4 opposite to the centre of Barn-road, near Saint Benedict's Gates, thence along the boundary of Ward No. 4 in a northerly direction to the boundary of Ward No. 5 thence in a northerly direction along the western boundary of Ward No. 5 to a point opposite to the centre of the Watering thence in a north-westerly direction along the centre of the River Wensum to the boundary of Ward No. 13, thence in a southerly direction along the eastern boundary of Ward No. 13 to the boundary of Ward No. 12 thence along the said boundary in an easterly direction to the boundary of Ward No. 4 thence in an easterly direction along the boundary of Ward No 4, to the point of commencement aforesaid.
