The importation of the following articles from France and Belgium is also prohibited:—Used linen, clothing, and bedclothes, rags, wadding, and shoddy.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated 2nd September, 1892, from Her Majesty's Representative at Stockholm, stating that the Swedish Government have declared the whole of Great Britain and Ireland to be infected with cholera. This involves 48 hours' quarantine on all vessels arriving there.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated 2nd September, 1892, from Her Majesty's Representative at Constantinople, stating that ten days' quarantine is imposed on arrivals from German ports, between Flensburg and the Dutch frontier, from Antwerp, and from Havre. Danish ports not in quarantine. This applies to departures since the 14th ultimo. Quarantine to be performed at Clazomene and Beirut.

Exception is made in favour of direct consignments from Mediterranean stations, and of fish and crustaceæ enclosed in hermetically closed boxes or glasses.
