THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following information respecting quarantine from Her Majesty's Consul-General at New York, viz.:

Quarantine regulations are September 23. enforced, but ships bringing steerage passengers have not been quarantined for twenty days as required by the President's Proclamation, some having been allowed when there has been no sickness on board and no passenger from infected ports (European) to come to the dock without detention except for a few hours. Ships bringing cabin passengers only from England have not been detained, except in a few instances, to disinfect luggage which had not been ten days from an infected European port. Where there have been cases of cholera, or the presumption of such on board ships arriving, quarantine regulations have been strictly enforced.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following Notice respecting quarantine :-

With reference to the notice respecting Government intervention abroad, with regard to quarantine restrictions, which was communicated to the newspapers on the 30th of July, the Secretary of State for Foreign Affairs desires to give notice that, as it appeared probable that the severe restrictions imposed against the United Kingdom in many countries resulted from an imperfect knowledge of the actual facts as regards the number of cases of cholera which had occurred in this country, and the circumstances attending them, Her Majesty's Representatives in Maritime States were instructed by telegraph, on the 19th September, to inform the Governments to which they are severally accredited that cholera had not, in this country, spread beyond persons who had arrived from abroad, and that on the day when the telegram was sent, there were hardly any cases in the United Kingdom.

Her Majesty's Representatives were again instructed by telegraph on the 3rd instant, to say that since the date of the previous telegram only two cases, both from abroad, had occurred in the United Kingdom, and that there had been no death.

For Sailing Vessels.

1. Medical inspection.

2. If there are any cases of suspected illness on board, or of death within fourteen days before arrival, quarantine of fourteen full days from the date of the last case.

3. Disinfection of linen and woollen effects, clothing of passengers and baggage, and of other objects considered specially liable to propagate disease.

For Steamers.

1. Medical inspection.

2. If fourteen days have not elapsed since the date of departure, or since the last case of suspected illness or death, quarantine of fourteen full days to count from the respective dates above alluded to.

3. Prohibition against the importation of used linen and clothing, of rags, and of other objects considered specially liable to propagate contagion.
