cholera infected ports, or bringing passengers or [cargo from such ports; and excepting all vessels from European ports with steerage passengers or having rags as cargo," from and after the 1st day of November next :

Therefore, I, Murphy J. Foster, Governor of the State of Louisiana, by virtue of the authority in me vested by law, do hereby revoke, annul, and withdraw the annual Proclamation of quarantine issued by my predecessor on the 14th day of April, A.D. 1892, said revocation, "excepting vessels arriving from cholera infected ports or bringing passengers or cargo from such ports; and excepting also vessels from European ports with steerage passengers or having rags as cargo," to go into effect from and after the 1st day of November, A.D. 1892.
