THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated 20th December, 1892, from Her Majesty's Representative at Hamburg, stating that Hamburg is declared to be infected by cholera. All other German Ports are suspected.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 17th December, 1892, from Her Majesty's Representative at Madrid, stating that the pratique granted to arrivals from Amsterdam is dependent on their having clean bills of health, duly visaed, being in good health on board, and otherwise not contravening other quarantine regulations.

"Dangerous" goods will be admitted into Spain, provided they have remained at Amsterdam during the epidemic, and do not leave that port before the 2nd January next.

The Royal Orders of the 25th and 29th August last are revoked so far as goods and passengers from Holland are concerned.
