2. On the 19th day of January, 1893, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair

TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in pursuance of the Acts relating to Her Majesty's Post Office, and in exercise of all powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), order, direct, and declare as follows:—

Repeal.

1. From and after the date when this Warrant comes into operation the Warrant of the Commissioners of Her Majesty's Treasury, dated the 15th day of December, 1891, and relating to the transmission of Parcels between the United Kingdom and British Bechuanaland and the Bechuanaland Protectorate, via Cape Town, shall be repealed, revoked, and annulled.

Definition.

2. In this Warrant-

(1.) The expression "Parcel" means a Postal Packet which is posted as a Parcel in accordance with the provisions of this Warrant, or any Warrant amending the same:

(2.) The expression "United Kingdom" includes the Channel Islands and the Isle of

Man.

Places between which Parcels may be transmitted.

3. From and after the date when this Warrant comes into operation Parcels may, subject to the provisions of this Warrant, be transmitted by post between the United Kingdom and British Bechuanaland, the Bechuanaland Protectorate, and Mashonaland, viâ Cape Town.

Rates of Postage.

4. On all Parcels transmitted by post under this Warrant between the United Kingdom and British Bechuanaland there shall be charged and paid the following rates of postage; that is to say:—

On every Parcel not exceeding one pound in

weight one shilling and threepence.

On every Parcel exceeding one pound and not exceeding seven pounds in weight for the first pound one shilling and threepence, and for every additional pound or fraction of a pound in weight one shilling and threepence.

5. On all parcels transmitted by post under this Warrant between the United Kingdom and the Bechuanaland Protectorate, the Trans Protectorate, or Mashonaland, there shall be charged and paid the following rates of postage, that is to say:—

On every parcel not exceeding one pound in

weight two shillings and twopence.

On every parcel exceeding one pound and not exceeding seven pounds in weight for the first pound two shillings and twopence, and for every additional pound or fraction of a pound in weight two shillings and twopence.
