THE following Notice, in continuation of the Notice published in the London Gazette of the 7th instant, respecting the Commission to enquire into alleged concessions in the Bechuanaland Protectorate, has been issued with the authority of Her Majesty's High Commissioner for South Africa:—

Notice No. 1.

The Concession Commission for the Bechuanaland Protectorate.

WHEREAS His Excellency the High Commissioner has been pleased to appoint a Commission to enquire into and report upon certain alleged land grants and mineral and other concessions claimed in the Bechuanaland Protectorate:

Notice is hereby given, that all claims to such alleged land grants and mineral and other concessions must be filed with the Secretary of the said Commission, at his office at Vryburg, British Bechuanaland, on or before the 1st May, 1893.

Every claim must be set forth in a document, to which shall be annexed such other original documents (and one set of copies of the same) as the claimant relies upon in support of his claim, or notarial copies of such original document, and one set of copies of such notarial copies: Provided that the filing of such notarial copies shall in no case be deemed to render unnecessary the due production at the inquiry into any claim of the original document or documents.
