THE FAIRS ACT, 1871. SOUTHEND FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices of the Peace acting for the Division of Rochford, in the county of Essex, that a Fair has been annually held on Whit Monday and several following days, in the Old Town, Southend, in the parish of Prittlewell, and that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas notice of the said representation, and of the time when I should take the same into

consideration, has been duly published in pursuance of "The Fairs Act, 1871:"

And whereas on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas the Mayor, Aldermen, and Burgesses of the borough of Southend, as owners of the said Fair and the tolls thereof, have consented, in writing, that the said Fair should be abolished.

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on Whit Monday and several following days, in the Old Town, Southend, in the parish of Prittlewell, shall be abolished as from the date of this Order.

GENERAL ORDER of the Local Government Board; Meetings of Boards of Guardians:—
To the Guardians of the Poor of the several
Unions and Separate Parishes in England

and Wales, except the Guardians of the Poor within the City of Oxford;—

And to all others whom it may concern.

WHEREAS by certain General and other
Orders from time to time issued by the Poor Law
Commissioners, the Poor Law Board, and by Us,
the Local Government Board, regulations have
been prescribed with respect to the holding of
the ordinary Meetings of the Board of Guardians
of each of the several Unions and Separate
Parishes above referred to;

And whereas it is expedient to make further provision on the subject as hereinafter mentioned:

Now therefore, in pursuance of the powers conferred upon Us by the Statutes in that behalf, We hereby Order as follows; that is to say,—

When the day for holding an ordinary Meeting of the Board of Guardians of any of the said Unions or Separate Parishes shall fall upon Good Friday, Christmas Day, a Bank Holiday, or a day appointed for a public fast or thanksgiving, such Meeting shall be held on such other day as the Board of Guardians may by resolution determine.
