continue to apply and extend to and be in force in that District until the Board of Agriculture by further Special Order direct and order; and the

Order of the Privy Council dated the sixteenth day of September, one thousand eight hundred and eighty-six, which applies the said provisions to certain Districts therein named, shall be read and have effect as if the District named in the Schedule to this Order was also named in that Order.

2. This Order shall take effect from and immediately after the fifteenth day of May, one thousand eight hundred and ninety-three.
