144 of 1893, and previous Notice:-

The French Government has given further notice, that on 18th June, 1893, a quick flashing electric light will be exhibited from the northern lighthouse on Cape de la Hève, north side of Seine River Entrance. This light will give white flashes every five seconds, preceded and followed by total eclipses; it is elevated 397 feet above high water, and should be visible in clear weather from a distance of 27 miles, but the glare may be seen considerably beyond that distance.

Also, that the present fixed electric light of the southern lighthouse on Cape de la Hève will be replaced by a fixed white light of the fifth order. This light kept in line with the northern electric light will indicate the anchorage in Havre Road.
