THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated 1st September, 1893, from Her Majesty's Representative at Athens, stating that ten days' quarantine is declared against Sebastopol and Black Sea ports between Atape (*sic*) inclusive and Batoum exclusive; five days' quarantine against ports between Batoum, inclusive, and Turkish frontier; the above apply to departures since the 26th ultimo, unless they underwent similar quarantine in Turkey.

ARRÊTÉ.

Nous, Mohamed Aziz Bou Attour, Premier Ministre de S. A. Le Bey. Vu l'arrêté du 28 Juillet, 1893 (15 Moharrem, 1311) relatif aux provenances d'Algérie par les voies de terre, Arrêtons:

ARTICLE UNIQUE.

Les articles 2 et 3 de l'arrêté du 28 Juillet 1893 (15 Moharem, 1311) sont modifiés ainsi qu'il suit:

ART. 2. Les caravanes ou voyageurs provenant d'Algérie ne peuvent franchir le cordon sanitaire établi par l'art. 1er ci-dessus que par la route joignant Tebessa à Feriana par Bou-Chebka.

ART. 3. La visite sanitaire des voyageurs et des caravanes pénétrant dans la Régence par la route indiquée à l'article 2 ci-dessus sera passée près du poste de douane de Bou-Chebka. Les désinfections des personnes, de leurs bagages, hardes, effets et marchandises dont l'introduction dans la Régence n'est pas formellement interdite par le décret ci-dessus visé du 5 Juillet, 1893 (21 Hidjé, 1310), se feront au même point.
