To authorise and empower the Company on the one hand, and the London and India Docks Joint Committee and the Millwall Dock Company, or either of those bodies, on the other hand, to enter into and carry into effect, vary, and rescind agreements and arrangements for and with respect to traffic entering and leaving the docks of or under the management of the respective contracting parties, and the inter-change and accommodation of traffic thereof, and the payments, drawbacks, compensations, rebates and allowances fixed or contingent to be made by any of the contracting parties to the other or others of them in respect of such traffic, and any other matter incident to the trade of the docks, of or under the management of the said.
