

proposed works to any extent defined by the Bill.

To authorize the Company to lay down, maintain, take up, alter, and repair mains, pipes, culverts, and other works for the distribution of water within their existing and extended limits of supply, and for that purpose, and for other purposes of the Bill, from time to time to open or break up, alter, divert, or stop up, temporarily or permanently, any turnpike, and other roads, streets, high ways, footpaths, bridges, canals, towing-paths, streams, watercourses, sewers, drains, railways, tramways, telegraph, telephone, and other electric apparatus.

To enable the Company to acquire by agreement, and, if necessary, by compulsion, and to hold lands, buildings, easements, waters, and property for the purposes of the reservoirs and other works to be authorized by the Bill, and of their undertaking, and to extinguish all manorial, commonable, and other rights, if any, over any such lands, buildings, and property.

To authorize the Company to sell, exchange, demise, and otherwise dispose of any lands not required for the purposes of their undertaking, and to confer upon the Company all such special or other powers or authorities as may be found necessary or expedient for that purpose.

To authorize and empower the Company to purchase and acquire, compulsorily or by agreement, a private footpath in the parish of Hampton, in the county of Middlesex, leading from the Lower Sunbury Road to the River Thames, and passing between and adjoining fields numbered 265 and 266 in the said parish of Hampton on the 25-inch Ordnance map of the county of Middlesex, and to extinguish and put an end to all rights and interests, whether public or private, over or in such right of way.

To confer upon the Company all such powers as may be found necessary or expedient for enabling them at any time and from time to time to unite all or any of the various portions of their lands and works which are not now united, and to connect any portion of such lands and works, with any other portion thereof, and for that purpose to authorize and empower the Company to purchase or otherwise acquire by agreement lands and other hereditaments, and also easements in, over, through, or under lands.

To authorize and empower the Company to take from the River Thames, impound and appropriate for the general purposes of their undertaking, and notwithstanding any statutory or other limit, prohibition, contract, or agreement, an additional quantity of water, to be defined by the Bill, beyond the quantity which they are now authorized to take, and for that purpose to alter, amend, and repeal, cancel, and annul all Acts of Parliament, contracts, agreements, and undertakings to the contrary.

To extend the limits within which the Company are authorized to supply water so as to include therein and enable the Company to supply water for all purposes to and within a small portion of the parish of Lewisham, in the county of London, consisting of the fields numbered 260a, 260, 258, and 336, in the said parish of Lewisham, on the 25-inch Ordnance map of the county of Kent.

To alter, amend, and, so far as may be necessary to repeal all or some of the provisions of the Richmond Footbridge, Sluices, Lock, and Slipway Act, 1890, and particularly Section 49 of that Act, so far as the same provisions relate to or affect the undertaking of the Company, and to exempt the Company from the payment of the special rate in the said section mentioned.

To enable the Company to apply their existing funds and any moneys which they have still power to raise for the purposes or any of the purposes of the Bill; and for the same purposes, and for the general purposes of their undertaking, to raise additional capital by shares or by stock, or by borrowing, and to make and enact such special provisions as to the raising and issue of such additional capital as the Bill may define, and to attach to such shares or stock any preference or priority of dividend, and any other advantage which the Bill may define.

To make provision for the consolidation or conversion, repayment, and reborrowing of all or some of the various classes or descriptions of debenture stocks of the company to such extent, by such means, and on and subject to such terms, conditions, and restrictions as may be prescribed or provided for by the Bill, and to alter and vary the rights and privileges now attaching to all or some of the existing debenture stocks of the Company, and to confer other rights, privileges, and exemptions, and to enable or require trustees, executors, administrators, guardians, and other persons under disability to accept any such consolidated or converted debenture stock in substitution for the debenture stock for the time being held by them.

To vary or extinguish all rights and privileges inconsistent with, or that may in any way interfere with any of the objects of the Bill, and to confer other rights and privileges.

To incorporate, extend, and make applicable to the purposes of the Bill all or some of the powers and provisions of the Lands Clauses Acts, the Waterworks Clauses Acts, 1847 and 1863.

To alter, amend, and repeal, so far as may be necessary for any of the purposes of the Bill, all or some of the provisions of the several Acts following, or some of them, that is to say:—The Southwark and Vauxhall Water Act, 1852, and any other Acts relating to the Company, and any other local and personal Acts which it may be necessary or expedient to alter, amend or repeal for any of the purposes of the Bill, and the Bill will or may further alter, amend, and, if need be, repeal for the purposes of the Bill the Metropolis Water Act, 1852, and the Metropolis Water Act, 1871, or certain of the provisions of those respective Acts.

Duplicate plans and sections describing the lines, situation, and levels of the proposed reservoirs, and other works, and the lands, houses, and other property in or through which they will be made, and also duplicate plans showing the lands, houses, and property intended to be taken compulsorily under the powers of the Bill, together with a book of reference to such plans, containing the names of the owners and lessees, or reputed owners and lessees, and of the occupiers of such lands, houses, and other property, and a copy of this Notice will, on or before the 30th day of November instant, be deposited for public inspection with the Clerk of the Peace for the county of London, at his office, at the Sessions House, Clerkenwell-green, in that county, and with the Clerk of the Peace for the county of Middlesex, at his office at the Guildhall, Westminster, in the county of London, and that on or before the said 30th day of November instant, a copy of so much of the said plans, sections, and book of reference as relates to each of the parishes, or extra-parochial, or other places in or through which the intended reservoirs and other works, or any part of them, are, or is intended to be made, or in which any
