Grimsby Extension and Improvement.

(Extension of Borough; Consequential Provisions as to Wards, Jurisdictions, Apportionment of Liabilities, &c.; Vesting Property and Powers in Corporation of Extended Borough; Power to Make New Streets, Widen Existing Streets, and Remove Footbridge; Purchase by Cor-poration of Waterworks Undertaking of Great Grimsby Waterworks Company, Limited, and Provisions with Reference to Supply of Water, and Rates and Charges, &c.; Power to Corporation to Advance Loans to School Board and Guardians of the Poor, and to Raise Money for the Purpose; Borrowing Powers, and Application and Investment of Corporation Funds, &c.; Rates and Charges; Compulsory Purchase of Lands, and Power to take Part of Property; Contributions in Respect of Improved Value of Lands; Entry for Survey and Valuation, &c.; Special Provisions as to Com-pensation; Provisions Relating to the Improvement, Good Government, and Police and Sanitary Regulations of the Extended Borough, and other Matters; Incorporation, Alteration, or Repeal of Acts.)

OTICE is hereby given, that application is intended to be made to Parliament in the next Session by the Mayor, Aldermen, and Burgesses of the borough of Grimsby, being the Municipal Authority, and also the Urban Sanitary Authority for the said borough (hereinafter referred to as "the Corporation"), for leave to bring in a Bill for effecting the following purposes, or some of them (that is to say):--

1. To extend the boundary of the municipal borough of Grimsby, so as to include therein (in addition to the existing borough) so much of the township of Cleethorpes and the district of the Local Board of Health for the district of Cleethorpes-with-Thrunscoe, in the parish of Clee, in the parts of Lindsey, in the county of Lincoln, as is situate immediately to the east of the existing borough and comprised within the limits of the area hereinafter described, viz. :- That portion of the township of Cleethorpes and the district of the Local Board of Health for the district of Cleethorpes which is bounded on the west by the present borough boundary, and by a line drawn from the extreme south east point where such boundary abuts upon the fence on the north-west side of Weelsby-road leading from Clee Village to Cleethorpes, thence north-eastwards along the said fence, and a line in continuance thereof in a north-easterly direction to a point at low water mark of ordinary tides in the River Humber, and thence westward or north-westward along the line of low water mark until it joins the extreme north-east point of the present borough boundary; or such other limits as may be defined in the Bill, either within or beyond the limits hereinbefore described. The said area proposed to be added to the borough is in this Notice re-ferred to as "the added area," and the present and proposed extended boundaries of the borough will be shown on a map to be deposited for public inspection with the Town Clerk of the borough as hereinafter mentioned.

2. To alter, if need be, the boundaries and names of the wards into which the existing borough is divided, and re-divide the borough as proposed to be extended (hereinafter referred to as "the extended borough") into wards, or to constitute the added area a new ward or wards, or to add the said area to the existing Humber Ward of the borough, and to determine the boundaries and names of the altered, re-divided, or new wards, and to alter the number of allermen and councillors, and to apportion them to their respective wards, and to provide for their nomination, election, going out of office and rotation, and to make provision in the Bill for the determining of all or any of the aforesaid matters.

3. To detach the added area from the jurisdiction of every Urban or Rural Sanitary Authority, Local Board, School Board, Highway and other Local Authority, having jurisdiction therein, and to rescind and annul all Resolutions and Pro-visional Orders whereby the Public Health, Local Government, Education, or Sanitary Acts, or any of them, have been put in force within the added area, or any part or parts thereof, and to repeal, so far as they relate thereto, or as may be deemed necessary or expedient, all Acts confirming such Orders, or putting in force such Acts or Act, and to transfer to the Corporation all or some of the lands, buildings, and property of, and of the estates, rights, powers, duties, and privileges, and liabilities vested in, or imposed on, the said Boards, Sanitary, and other Local Authorities respectively, and to provide for the satisfaction or apportionment of their respective debts, liabilities, and obligations, the apportion-ment of current rates, and for the making of compensation to any officer wholly or partially displaced by reason of the extension of the borough.

4. To exempt the added area from the payment of county, highway, sanitary, district, local, and other rates, which now are, or which by law might be levied within such area, and to make provision for the repair of the roads and bridges therein, or any of them respectively, and (if thought fit) for the transfer of such roads and bridges, or any of them respectively to the Corporation, and to make provision with respect to the apportionment, recovery, and application of the aforesaid rates, or any of them.

5. To vest the property of the present Corporation in the Corporation of the extended borough, and to authorise the Corporation (subject to any modifications contained in the Bill) to put in force within the extended borough all such powers as are now vested in them by charter, custom, or prescription, or under any public or local Acts, or as a Municipal Corpora-tion, Local Board of Health, Urban Sanitary Authority, Burial Board, or otherwise, and as may be contained in the Bill; to extend to the added area, with or without alteration, the provisions of the Grimsby Pastures Act, 1849; thé Great Grimsby Improvement Act, 1853; the Grimsby Improvement Act, 1869; and the Grimsby Extension and Improvement Act, 1889; and all other local Acts affecting the existing borough, and also the provisions of the Grimsby Provisional Order confirmed by the Local Government Board's Provisional Orders Confirmation (No. 15) Act, 1890, and the Grimsby Pro-visional Order confirmed by the Local Govern-ment Board's Provisional Orders Confirmation (No. 12) Act, 1891, and any bye-laws made under the said Acts or Provisional Orders respectively, and the benefit of any estates, funds, or
