street before the erection of buildings, crossings over footways for horses and vehicles, recovery of damages caused to footways, or carriageways by excavations, undertakings given to or by the Corporation to bind successive owners, regulations as to sewers and drains, projections in streets, the removal of house refuse by means of portable ash-boxes or other receptacles, power to charge for the emptying of privies and ashpits and removal of rubbish, as to pipes from slop-stones, temporary or urgent repairs of streets, laying open and inspection of work.

To make further and better provision in regard to the prevention and spread of infectious diseases and other sanitary matters and things both within and beyond the city, and particularly relating to the following:—To require cowkeepers and others to furnish lists of their customers, and to require persons engaged in washing or mangling clothes to furnish lists of the owners of such clothes or Customers; to make regulations in regard to the admission and discharge of persons to or from infectious hospitals, and as to persons visiting such hospitals; to require dairymen to give listof farms from which they obtain their milk, dairymen and others to notify infectious disease of their servants, infected persons not to carry on business, removal of infected persons not properly isolated; to prohibit the sending of diseased food and penalty on original sender: to prohibit the blowing or stuffing of carcases; to prohibit manure pits near to dwellings or streets; further powers of entry and inspection; power to apply the smoke and other tests to drains; to require inns and other places of public entertainment to provide urinals; and to make other provisions for the health and comfort of the inhabitants of the city.

I'o prohibit under penalty the holding of any unlicensed markets or fairs within the city, to license porters and carriers within the market limits, to regulate sales by auction in the markets, to provide for the forfeiture or disposal of articles left in the markets, and in other respects to make further and better provision in regard to the markets and fairs of the Corporation.

To restrict, license or regulate advertising hoardings, sky signs, and advertising vehicles; and to make other provision in regard to street advertisements.

To provide for the repair, cleansing, straightening, concreting and arching over by the Corporation of all streams and watercourses within the city, and for empowering the Corporation to enter adjoining lands, to execute and do all necessary works and things in relation to such streams and watercourses, and to provide for the cost of such works.

To make better provision in regard to slaughter-houses, the slaughtering of horses, cattle, sheep, and other animals, and to prohibit the slaughter of any animal except in a Corporation slaughter-house when provided.

To extend the operation of the enactments and bye-laws relating to hackney carriages, omnibuses, and vehicles to places beyond the city, and for such distance as may be prescribed by the intended Act, to empower the Corporation to inspect hackney carriages, omnibuses, and other public vehicles, to provide that a railway station shall be deemed a public stand for hackney carriages and other vehicles, and in other respects to make better provision in relation to hackney carriages, stage coaches, omnibuses and other public vehicles and their owners, drivers, and conductors.

registration, control, management, and supervision of common lodging-houses, for imposing penalties on persons keeping a lodging-house not duly registered, to empower the Corporation to refuse to register any person as a common lodging-house keeper unless satisfied of his character and fitness, and to require proper sanitary conveniences to be provided for lodgers, power to cancel the registration on the keeper of a common lodging-house being convicted of certain offences, and in other respects to alter and amend the law relating to common lodging-houses within the city.

To authorize telegraphic and telephonic communications within and beyond the city between the municipal offices and the water and other works and sanitary depôts of the Corporation, and residences of officers of the Corporation, and between the various Fire Brigade stations, and Police station, and to incorporate all or some of the provisions of the Telegraph Acts, 1863 to 1889, in relation to the matters aforesaid.

To empower the Corporation to borrow money for all or any of the purposes of the intended Act, and to charge the moneys so proposed to be borrowed on the City Fund and Rate, the District Fund and General District Rate or other local rates, and the estates, undertakings, tolls, rates, rents, revenues, and other property of the Corporation or any of such securities, and to execute and grant mortgages, debentures, debenture stock, and annuities in respect thereof, and to authorize the Corporation to apply any of their funds or any money borrowed or authorized to be borrowed under former Acts to all or any of the purposes of the intended Act.

To make further and better provision for the collection and recovery of rates (including poor rates and water rates, rents, and charges), and the keeping and form of rate books.

To empower the Corporation to grant gra-. tuities to any of their officers or servants (or their widows or families) injured, dying, or becoming incapacitated whilst in their service.

To make better provision in regard to matters of police and local government, particularly with regard to the following:—To require street musicians to depart when requested, to prohibit the assembling of persons in streets for betting purposes, to prohibit the obstruction of streets and annoyance of passengers, and to extend the Vagrancy Act, 1824, to unfenced ground adjoining any street.

To make provision for the authentication and services of notices and other documents and for the prosecution of offences.

To empower officers of the Corporation to lay informations and make complaints under any general or local Act within the city or any byelaws thereunder, to make better provision as to evidence of any appointment or authority, and in other respects to amend the law in regard to summary and other proceedings under any local or general Acts in force within the city.

To amend the local Act 4 Wm. IV., cap. 44 ("To provide for the lighting of the suburbs of the city of Gloucester with gas") so as to extend the limits or district of that Act, but so as not to exceed two miles from the boundary of the

To empower the Corporation to impose penalties for breach or non-compliance with the provisions of the intended Act, to make and enforce bye-laws in respect of all or some of the matters and things mentioned or referred to in this Notice, and to impose penalties for the To make better provision with regard to the breach of such bye-laws, and to extend the
