High Court of Justice in Bankruptcy	1279 of 1893	Dec. 14, 1893	Debtor to set aside out of his salary as Assistant Director of Transports, the sum of £300 per annum, such sum to be paid by quarterly payments to the Official Receiver until his debts shall have been paid in full, with interest thereon, as directed by the Bankruptcy Acts. Provided that in the event of his retirement from active service during the continuance of this Scheme, then from the date of such retirement the allocation out of his pension shall be at the rate of £200 per annum. To secure the payment of such debts the Official Receiver may effect an insurance on the life of the debtor for the sum of £1,000, the premiums on such policy to be paid by the Official Receiver out of the aforesaid payments from salary or pension. Preferential debts and all proper costs, charges, and expenses to be provided for by the deposit of the amount required with the Official Receiver prior to the hearing of the application to approve this Scheme; and as to future expenses, fees, and percentages, payment to be made out of the amount to be received by the Official Receiver under the terms of this Scheme. Upon payment of his debts in full, with interest, any policy of insurance effected in pursuance of this Scheme shall be assigned to or vested in the debtor. Receiving Order discharged

To pay to all unsecured creditors (other than to two creditors for £1,019 0s. 10d. and £1,021 3s. 3d. respectively, whose claims are to be withdrawn) in respect of all debts provable under the Receiving Order herein, and in full satisfaction and discharge of the same, a Composition of 10s. in the pound, payable by two instalments, namely, 7s. 6d. in the pound, immediately upon the said approval by the Court, and 2s. 6d. in the pound within nine months from the date of such approval. Payment of the aforesaid preferential debts, fees, costs, charges, and expenses, and the first instalment of such Composition, to be secured by a deposit by Mr. Thomas Oswald Jones, of 42, Welbeck-street, Cavendish-square, in the county of London, with the Official Receiver of the amount required therefor, prior to the application to the Court to approve the Composition arrangement. The joint and several promissory note of the debtor and of the said Thomas Oswald Jones for the amount required for the second instalment, payable nine months after date of the said approval, to be deposited with the Official Receiver prior to the application for the said approval by the Court.
