THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 5th January, 1894, from Her Majesty's Representative at Lisbon, transmitting the following quarantine potice :-

Notice.

It is hereby notified, for the proper purposes, that, by order of the Government, and on the recommendation of the Consultative Board of Public Health, vessels coming from India, China, Japan, and Java will be admitted to free pratique at the port of Ponta Delgada (St. Michaels-Azores), for the sole purpose of receiving coal or supplies, provided they hold clean bills of health and are in a good sanitary condition, and when they shall have been admitted to free pratique at all the ports at which they may have called, and the length of the voyage shall have been more than forty days; and, even so, the hatchways must be kept entirely closed during the stay of the vessels in that port.
