

ward, as to the aggregate amount of the sums at which all such persons are rated, and the number of vestrymen assigned to each ward shall be a number divisible by three.

And whereas the parish of St. Mary, Stratford-le-Bow, is within the limits of the Metropolis, as defined by the Metropolis Management Act, 1855, and is one of the parishes in Part 1 of Schedule B of that Act, and was not at the passing of the Metropolis Management Amendment Act, 1862, divided into wards.

And whereas the powers, duties, and liabilities of the Metropolitan Board of Works were transferred to the London County Council by the Local Government Act, 1888.

And whereas application has been made by more than five hundred rated householders of the parish of St. Mary, Stratford-le-Bow to us, the London County Council, to divide the said parish into wards, pursuant to the provisions of the said 41st Section of the Metropolis Management Amendment Act, 1862.

And whereas it appears from the last account taken of the population by the Authority of Parliament that the said parish contains five thousand eight hundred and nine rated householders.

And whereas it appears from the rate books of the said parish prepared in the year one thousand eight hundred and ninety-three that

the rateable annual value of property in the said parish was one hundred and forty-five thousand five hundred and forty-one pounds.

Now the London County Council having considered the said application, and having ascertained from the said last account taken of the population by the Authority of Parliament, as contained in the census return for the year one thousand eight hundred and ninety-one that the number of rated householders for the parish of St. Mary, Stratford-le-Bow, was then five thousand eight hundred and nine, and having taken into consideration the number of persons rated to the relief of the poor in the said parish, and the aggregate amount of the sums, at which all such persons are rated as shown by the said rate books of the parish for one thousand eight hundred and ninety-three and all the circumstances connected with such application, doth hereby order that the said parish of St. Mary, Stratford-le-Bow be divided into four wards, to be distinguished by the numbers mentioned in the first column of the undermentioned schedule; that the extent, limits and boundary lines of such wards shall be those described in the second column of the said schedule, and that the number of vestrymen to be elected for each of the said wards shall be the number mentioned in the third column of the said schedule.

Ward No. 1.	Comprising all that part of the parish of St. Mary, Stratford-le-Bow; bounded on the west by the parish boundary from the point where it is intersected by Sir George Duckett's canal to the limit of the western boundary in Victoria-park; on the north by the parish boundary; on the east by the parish boundary as far as the embankment of the northern outfall; on the south by a line drawn along the centre of the embankment of the northern outfall to its terminus, and thence at the back of the houses in Candy-street to Parnell-road; along the centre of Parnell-road as far as Sir George Duckett's canal; along the centre of Sir George Duckett's canal to the parish boundary on the west.	15
Ward No. 2.	Comprising all that part of the parish of St. Mary, Stratford-le-Bow, bounded on the west by a line drawn along the centre of the North London Railway from the point where that railway is intersected by the Great Eastern Railway as far as Tredegar-road, along the centre of Tredegar-road as far as Parnell-road, along the centre of Parnell-road to the point opposite the boundary wall of the houses in Candy-street; on the north by a line drawn along the boundary wall of the houses in Candy-street and the centre of the embankment of the northern outfall to the parish boundary on the east; on the east by the parish boundary from the point where it is intersected by the embankment of the northern outfall to the point where it is intersected by the Great Eastern Railway; on the south by a line drawn along the centre of the Great Eastern Railway from the parish boundary; on the east to the point where it is intersected by the North London Railway.	15

Comprising all that part of the parish of St. Mary, Stratford-le-Bow, bounded on the west by the parish boundary from the point where it is intersected by the Great Eastern Railway to the point where it is intersected by Sir George Duckett's Canal; on the north by a line drawn along the centre of Sir George Duckett's Canal as far as Parnell-road; on the east by a line drawn along the centre of Parnell-road from Sir George Duckett's Canal, as far as Tredegar-road, along the centre of Tredegar-road as far as the North London Railway, along the centre of the North London Railway to the point
