Holland Ward.	Comprising all that part of the parish of Kensington bounded on the west by the parish boundary from Kensington-road to Uxbridge-road; on the north by a line drawn along the centre of Uxbridge-road and High-street, Notting-hill, from the parish boundary on the west to the parish boundary on the east; on the east by the parish boundary from High-street, Notting-hill, to High-street, Kensington; on the south by a line drawn along the centre of High-street, Kensington, and Kensington-road, from the parish boundary on the east to the parish boundary on the west	15
Earl's-court Ward.	Comprising all that part of the parish of Kensington bounded on the west by the parish boundary from Richmond-road to Kensington-road; on the north by a line drawn along the centre of Kensington-road and High-street, Kensington, from the parish boundary on the west to Wright's-lane; on the east by a line drawn along the centre of Wright's-lane and Cheniston-gardens from High-street, Kensington, to Marloes-road, along the centre of Marloes-road from Cheniston-gardens to Cromwell-road, along the centre of Cromwell-road from Marloes-road to Earls-court-road, and along the centre of Earls-court-road from Cromwell-road to Richmond-road; on the south by a line drawn along the centre of Richmond-road from Earls-court-road to the parish boundary on the west	12
Queen's gate Ward.	Comprising all that part of the parish of Kensington bounded on the west by a line drawn along the centre of Marloes-road to Cheniston-gardens, along the centre of Cheniston-gardens and Wright's-lane from Marloes-road to High-street, Kensington; on the north by a line drawn along the centre of High-street, Kensington, from Wright's-lane to the parish boundary on the east, and thence by the parish boundary along the Kensington-road; on the east by the parish boundary from Kensington-road to Exhibition-road, and thence by a line drawn along the centre of Exhibition-road to Cromwell-road; on the south by a line drawn along the centre of Cromwell-road from Exhibition-road to Marloes-road	15
Redcliffe Ward.	Comprising all that part of the parish of Kensington bounded on the west by the parish boundary from the south-western corner of the parish to Richmond-road, and thence by a line drawn along the centre of Richmond-road, from the parish boundary on the west to Earl's-court-road, and along the centre of Earl's-court-road from Richmond-road to Cromwell-road; on the north by a line drawn along the centre of Cromwell-road from Earl's-court-road to Gloucester-road; on the east by a line drawn along the centre of Gloucester-road and Cranley-gardens from Cromwell-road to the parish boundary; on the south by the parish boundary from Cranley-gardens to the south-western corner of the parish	15
Brompton Ward.	Comprising all that part of the parish of Kensington bounded on the west by a line drawn along the centre of Cranley-gardens and Gloucester-road from the parish boundary on the south to Cromwell-road; on the north by a line drawn along the centre of Cromwell-road from Gloucester-road to Exhibition-road, along the centre of Exhibition-road from Cromwell-road to the parish boundary on the north, and thence by the parish boundary to the easternmost corner of the parish; on the east by the parish boundary from the easternmost corner of the parish to Crauley-gardens	120
