THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 11th August, 1894, from Her Majesty's Representative at Rome, enclosing a Quarantine Notice issued by the Italian Government to the effect that arrivals from French ports of the Mediterranean are subjected to the provisions of the Maritime Sanitary Ordinance of the 11th November, 1892. The main points of this Ordinance are that ships from the above ports will be subjected to a rigorous medical visit and disinfection of clothes, linen, &c.

In case of cholera having occurred during the voyage, or if there is suspicion of cholera on arrival, the ship will be sent to the quarantine stations at Asinbara or Poveglia.
