Comprising all that part of the parish of Wandsworth bounded on the west by the parish boundary from the south-western corner of the parish to Kingston-road; on the north by a line drawn along the centre of Kingston-road from the parish boundary on the west to West-hill, along the centre of West-hill and High-street to the river Wandle; on the east by the river Wandle from High-street to the parish boundary on the south; on the south by the parish boundary from the river Wandle to the south-western corner of the parish ... ..	21
Northfield ...	Comprising all that part of the parish of Wandsworth bounded on the west and north by the parish boundary from Kingston-road to the river Wandle; on the east by the river Wandle from the parish boundary in the river Thames to High-street; on the south by a line drawn along the centre of High-street from the river Wandle to West-hill, and along the centre of West-hill and Kingston-road to the parish boundary ... ..	15
Fairfield ...	Comprising all that part of the parish of Wandsworth bounded on the west by the river Wandle from High-street to the parish boundary in the river Thames; on the north and east by the parish boundary from the river Wandle to St. John's-hill; on the south by a line drawn along the centre of St. John's-hill from the parish boundary to East-hill, thence along the centre of East-hill and High-street to the river Wandle... ..	24
Heathfield ...	Comprising all that part of the parish of Wandsworth bounded on the west by the river Wandle from a point opposite Allfarthing-lane to High-street; on the north by a line drawn along the centre of High-street from the river Wandle to East-hill, along the centre of East-hill and St. John's-hill to the parish boundary, and thence by the parish boundary to the London and South Western Railway; on the east by the London and South Western Railway from the parish boundary on the east to Heathfield-road; on the south by a line drawn along the centre of Heathfield-road from the London and South Western Railway to Allfarthing-lane, along the centre of Allfarthing-lane from Heathfield-road to Garratt-lane, and thence by a line in continuation of Allfarthing-lane to the river Wandle ... ..	15

Comprising all that part of the parish of Wandsworth bounded on the west by the parish boundary from the London and South Western Railway to the river Wandle, and thence by the river Wandle to a point opposite Allfarthing-lane; on the north by a line drawn from a point to the river Wandle opposite Allfarthing-lane to and along the centre of Allfarthing-lane as far as Heathfield-road, and along the centre of Heathfield-road to the London and South Western Railway; on the south-east by the London and South Western Railway from Heathfield-road to the parish boundary on the south ... ..	15
