

otherwise 'Saint Peter's' Ward shall comprise so much of the area of the county borough of Brighton as is contained within a line commencing from the point of intersection of the boundary of Ward No. 8, with the boundary of Ward No. 9, opposite to the centre of Richmond-street, thence in a westerly direction along the boundary of Ward No. 8 to the eastern boundary of Ward No. 7 thence in a northerly direction along the said boundary to the point in New England-road in the boundary of the parishes of Brighton and Preston, thence in an easterly direction along the said parochial boundary to the boundary of Ward No. 11, thence in a southerly, easterly, and southerly direction along the said boundary to the point of commencement aforesaid.

And I do hereby determine that Ward No. 13 otherwise 'Preston Park' Ward shall comprise so much of the area of the county borough of Brighton as is contained within a line commencing from the point of intersection of the boundary of the county borough with the parochial boundary of Preston in the Old Shoreham-road near Prestonville-road, thence in a westerly direction along the said parochial boundary to the boundary of the county borough in Dyke-road, thence in a northerly and easterly direction along the boundary of the county borough to a point in the centre of the Ditchling-road, thence in a southerly direction along the centre of Ditchling-road to a point opposite to the centre of Preston Drove, thence in a westerly direction to and along the centre of Preston Drove to a point opposite to the fence forming the eastern boundary of Preston Park, thence in a southerly direction for a distance of forty-four linear feet to the said fence, thence in a southerly direction along the said fence of Preston Park to a point in the centre of Stanford-avenue, thence in a south-westerly direction along the centre of Stanford-avenue to the centre of Preston-road, thence in a south-easterly direction along the centre of Preston-road to the boundary of Ward No. 12, thence in a westerly direction along the said boundary to the boundary of Ward No. 7, thence in a westerly direction along the said boundary to the point of commencement aforesaid.

And I do hereby determine that Ward No. 14 otherwise 'Preston' Ward shall comprise so much of the area of the county borough of Brighton as is contained within a line commencing from the point of intersection of the boundary of Ward No. 11 and of the boundary of Ward No. 12 at Viaduct-road thence in a westerly direction along the boundary of Ward No. 12, to the boundary of Ward No. 13, thence in a north-westerly, northerly, easterly, and northerly direction along the said boundary to the boundary of the county borough, thence in an easterly and southerly direction along the said boundary of the county borough to the boundary of the parishes of Brighton and Preston aforesaid, thence in a westerly and southerly direction along the said parochial boundary to the point of commencement aforesaid.

And I the said Charles Nere Cresswell by virtue of the powers given to me by the aforesaid warrant of appointment and in accordance with the provisions of the thirtieth section of the Municipal Corporations Act 1882 do hereby assign and apportion to each of the said fourteen wards hereby determined three Councillors in due order of rotation as follows, that is to say:—
