#### TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in pursuance of the Acts relating to Her Majesty's Post Office, and in exercise of all powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), order, direct, and declare as follows:—

#### Definitions.

1. In this Warrant—

(1.) The expression "Parcel" means a Postal Packet which is posted as a Parcel in accordance with the provisions of this Warrant, or any Warrant amending the same:

(2.) The expression "United Kingdom" includes the Channel Islands and the Isle of Man.

*Places between which Parcels may be transmitted.*

2. From and after the date when this Warrant comes into operation Parcels may, subject to the provisions of this Warrant, be transmitted by post between the United Kingdom and the Dutch West Indies, and Dutch Guiana via the Netherlands.

#### Rates of Postage.

3. On all Parcels transmitted by post under this Warrant from the United Kingdom to the Dutch West Indies or Dutch Guiana, there shall be charged and paid the following rates of postages; that is to say:—

On every Parcel not exceeding three pounds in weight three shillings and sixpence.
