

Law, and Rules 1, 9, 10, 11, and 14 of the Royal Order of the 23rd of September, 1892, arrivals from that port are declared clean whatever their date of departure. In virtue of this the said arrivals, as well as those from ports within 165 kilometres of Paita shall henceforth be admitted to free pratique if they arrive with clean bill of health visé by the Spanish Consul, or if there be none, by that of another nation, in good hygienic conditions and without suspicious occurrence in the health of the ship, so long as they do not infringe Rules 9, 10, or 11 of the Royal Order of the 31st of March, 1888, 29, 31, or 32 of that of the 23rd of September, 1892, or any other enactment subjecting ships to quarantine owing to circumstances of the voyage, or from the ports referred to in this declaration, proving to be within 165 kilometres of another declared foul.

Infectious goods, as laid down in the Royal Order of the 29th of October, 1885, which have remained in Paita during the epidemic, shall likewise be admitted without disinfection, irrespective of date, if in good hygienic conditions.

In view of official intelligence of the termination of cholera in Marseilles, and in conformity with Article 30 of the Sanitary Law, and Rules 1, 9, and 11 of the Royal Order of the 23rd of September, 1892, arrivals which have left that port after the 20th ultimo are declared clean so long as they do not infringe any of the general enactments imposing quarantine.

Infectious goods shall likewise be admitted subject to the conditions of the preceding Royal Order.

THE Board of Trade have received, through the Secretary of State for the Colonies, a copy of a Quarantine Notice issued by the Governor of Malta, No. 161, from which it appears that Notice No. 157, already published, has been amended by the omission of the following paragraph, viz. :—

The following shall be subject to a quarantine of five days, but shall be permitted, under the directions of the Collector of Customs, to discharge goods (which are not susceptible of communicating contagion) by means of the vessel's crew on lighters, or to employ for handling cargo local labourers subject to five days' quarantine, viz. :—

Vessels from ports of Turkey in Asia in the Black Sea, and from ports of European Turkey between Marona and Enos, inclusive.

Passengers will not be permitted to land at Malta unless they declare on oath that they have not resided or been in ports of European Turkey, between Marona and Enos inclusive, for nine days previous to their arrival.
