

**ORDER RE-ARRANGING THE WARDS  
OF THE PARISH OF CAMBERWELL.**

WHEREAS the London County Council, in pursuance of the powers conferred on them by Section 15 of the London County Council (General Powers) Act, 1893, have prepared an Order, dated the twenty-fourth day of July, one thousand eight hundred and ninety-four, re-arranging the wards of the parish of Camberwell, being a parish mentioned in Schedules A and B to the Metropolis Management Act, 1855, and determining the number, limits, and boundary lines of the new wards, and apportioning among the several wards the number of vestrymen to be elected for such parish, in accordance with the limitations prescribed by the said Section.

And whereas such Order was transmitted to me for approval on the ninth day of August, one thousand eight hundred and ninety-four, and was published in the London Gazette on the fourteenth day of August, one thousand eight hundred and ninety-four.

And whereas power is given to me by the said Section, if I disapprove of the proposed re-arrangement of wards or apportionment of

vestrymen, to make, subject to the limitations prescribed in the said Section, such other Order as to the re-arrangement or apportionment as in my judgment shall be more conducive to a fair representation in the vestry of the interests of the ratepayers of the parish.

And whereas I disapprove of the re-arrangement into wards of the parish of Camberwell proposed in the said Order of the London County Council.

I hereby, in pursuance of the said power, order that the wards of the said parish of Camberwell be re-arranged in manner following, namely, that the said parish be divided into eight wards, that the eight wards be distinguished by the number and names mentioned in the first column of the Schedule hereto, that the extent, limits, and boundary lines of such wards shall be those described in the second column of the said Schedule, and that the number of vestrymen to be elected for each of the said wards shall be the number mentioned in the third column of the said Schedule.

Comprising all that part of the parish of Camberwell bounded on the west by a line drawn along the centre of Wells-street and across Albany-road from the Grand Surrey Canal to the parish boundary on the north; on the north and east by the parish boundary from a point opposite Wells-street to the Grand Surrey Canal; on the south by the Grand Surrey Canal from the parish boundary on the east to Wells-street .. ..	12
