(Swine-Fever Infected Area.)
By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Act, 1894, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area declared by Order of the Board dated the seventh day of December, one thousand eight hundred and ninety-four to be an Area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order of 1894, No. 3 (namely),—the county of Worcester (except the chapelry of Cutsdean, the parishes of Daylesford, and Evenlode, and the hamlet of Teddington, transferred by Agreement to the county of Gloucester, and except the parishes of Alderminster, Oldberrow, Shipston-on-Stour, Tidmington, Tredington, and Yardley, transferred by Agreement to the county of Warwick), and also comprising the boroughs of Dudley, Kiddermin-ster, and Worcester, and also comprising the parish of Upper Arley transferred by Agreement to the county of Worcester from the county of Stafford,is, except such portion thereof as is included in the Area described in the Schedule to this Order, hereby declared to be free from swine-fever, and the Area above described, except as aforesaid, shall as from the commencement of this Order cease to be an Area infected with swine-fever.

2. The Area described in the Schedule to this Order shall as from the commencement of this Order continue to be and is hereby declared to be an Area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order

of 1894, No. 3.
3. This Order shall come into operation on the eleventh day of April, one thousand eight hundred and ninety-five.
