By the QUEEN. A PROCLAMATION.

VICTORIA, R.

WHEREAS by an Act passed in the thirtythird year of Our Reign intituled "An Act to consolidate and amend the law relating to the Coinage and Her Majesty's Mint" it is amongst other things enacted :

That We, by and with the advice of Our Privy Council, shall from time to time by Proclamation determine the design of any coin :

We have, therefore, thought fit to order that the coins of bronze or mixed metal made at Our Mint which are mentioned in the first schedule to the aforesaid Act, of the weight specified in that schedule, shall bear designs as follows:

That every Penny should have for the obverse impression Our Effigy, with the Inscription "Victoria Dei Gra. Britt. Regina Fid. Def., Ind. Imp.," and for the reverse impression the figure of Britannia seated upon a Rock in the Sea, her right hand holding a Shield which rests against the Rock, while in her left hand she grasps a Trident, and the inscription "One Penny," with the date of the year and a plain edge; and that every Halfpenny should have the same obverse impression and inscription, and for the reverse the figure of Britannia seated as, described for the Penny, and the inscription "Half Penny," with the date of the year and a plain edge ; and that every Farthing should have the same obverse impression and inscription, and for the reverse the figure of Britannia seated as described for the Penny, and the inscription "Farthing," with the date of the year and a plain edge.

And whereas pieces of money of the above descriptions respectively have been coined at Our Mint, and will be coined there, in pursuance of Orders which We have given for that purpose, We have, therefore, by and with the advice of Our Privy Council, thought fit to issue this Our Royal Proclamation, and We do hereby ordain, declare, and command that the said pieces of money respectively so coined, and to be coined as aforesaid shall be current and lawful money of the United Kingdom of Great Britain and Ireland, and that this Our Royal Proclamation shall come into operation on the date hereof.

STATUTES to alter and amend the Statutes framed by the Commissioners appointed under "The Universities of Oxford and Cambridge Act, 1877, forty and forty-one Victoria, cap. forty-eight, and approved by the Queen in Council on the third day of May, one thousand eight hundred and eighty-two, in relation to Jesus College in the University of Oxford, such amending Statutes being duly made at a general meeting of the Governing Body of the said College specially summoned for this purpose held on the second day of May, one thousand eight hundred and ninetyfive, and passed by the unanimous votes of those present and voting, in accordance with section fifty-four of "The Universities of Oxford and Cambridge Act, 1877."
