Treasury Chambers, May 21, 1895.

THE Chancellor of the Exchequer has appointed Sidney Herbert to be Steward and Bailiff of the Chiltern Hundreds.

IN pursuance of the powers given by the County Courts Acts and of all other powers enabling Us in this behalf, We the undersigned being two of the Lords Commissioners of Her Majesty's Treasury do hereby, with the consent of the Lord Chancellor order that on and after the 1st of June 1895 the following alterations shall take effect in Our Order relating to Court Fees of the 1st of January 1889, viz. :—

In paragraph 6 ("For every hearing") the following words shall be added:—

"Where before an action or matter is called on for trial or in opening his case when called on, the plaintiff abandons any part of his claim, the hearing fee shall be charged only on the reduced amount which the plaintiff seeks to recover after such abandonment, including therein the amount (if any) paid into Court or otherwise admitted by the defendant."

In paragraph 7 ("In all cases," etc.) the following words shall be inserted between the words "claim" and "one" in the second line, viz. :—

"Or where the Judge or Registrar accepts a letter addressed to the Court as an admission of the claim."

Paragraph 9 ("The hearing fee on interpleader") shall read as follows:—

"The hearing fee on interpleader shall be prepaid by the claimant, and shall be estimated on the amount of the money in Court or in the hands of the Sheriff, or the assessed value of the goods claimed, or, if such value has not been assessed, the value put upon them by the claimant, plus in either case the amount of the damages (if any) claimed; and the Judge at the hearing shall direct by whom such fee shall be ultimately borne."
