WHEREAS, by "The Foreign Marriage Act, 1892," Her Majesty the Queen in Council is authorized to make Regulations for the purposes therein specified;

Now, therefore, Her Majesty, by virtue and in exercise of the powers conferred by the said Act or otherwise enabling Her in this behalf, is pleased, by and with the advice of Her Privy . Council, to order, and it is hereby ordered, as

follows:

.1. A British Consul, or person authorized to act as British Consul, shall not, under the provisions of section 18 of "The Foreign Marriage Act, 1892," or Article 8 of "The Foreign Marriages Order in Council, 1892," register any marriages solemnized in accordance with the local law of a foreign country, unless he is a marriage officer, or is, for the time being, nuthorized by a Secretary of State to register such marriages; and no Consular Officer shall be required to attend at the solemnization of any marriage so solemnized unless he is by, or in pursuance of, this Order authorized to register such marriage.

2. This Order may be cited as "The Foreign Marriages Order in Council, 1895."

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty,

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the eighth and ninth years of Your Majesty, chapter seventy, of the Act of the fourteenth and fiftcenth years of Your Majesty, chapter ninety-seven, of the Act of the nineteenth and twentieth years of Your Majesty chapter fifty-five, and of the Act of the thirtyfourth and thirty-fifth years of Your Majesty, chapter eighty-two, have prepared, and now humbly

representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Thomas Bradley situate within the limits of the new parish (sometime chapelry district) of Christ Church Woodhouse in the county of York and in the diocese of Wakefield.

"Whereas at certain extremities of the said new parish of Christ Church Woodhouse, of the new parish (sometime particular district) of Saint John the Evangelist Bay Hall in the said county and diocese, and of the parish of Kirkheaton in the same county and diocese which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such new parishes and of such parish respectively.

" And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of Christ Church Woodhouse of the said new parish of Saint John the Evangelist Bay Hall and of the said parish of Kirkheaton should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint

Thomas Bradley situate as aforesaid.

"Now therefore, with the consent of the Right Reverend William Walsham Bishop of the said diocese of Wakefield as such Bishop and also as the patron in right of his Sec of the vicarage of the said new parish of Christ Church Woodhouse with the consent of Sir John William Ramsden of Byram Ferrybridge in the said county of York Baronet the patron of the vicarage of the said new parish of Saint John the Evangelist Bay Hall, and with the consents of the Right Reverend Norman Bishop of the diocese of Sodor and Man, the Reverend Frederic Edward Wigram of Oak Hill House Hampstead in the county of Middlesex Clerk in Holy Orders, the Reverend Hanmer William Webb-Peploe of number 25 Onslow-gardens in the said county of Middlesex Prebendary of the cathedral church of Saint Paul in the diocese of London Edmund Smith Hanbury of Poles, Ware, in the county of Hertford Esquire, William Donaldson Cruddas of Elswick Dene, Newcastle-upon-Tyne in the county of Northumberland Esquire Charles Holehouse Bousfield of number 40 Elvaston-place in the said county of Middlesex Esquire and the Reverend George Ferris Whidborne of Saint George's Vicarage Battersea Park-road in the county of Surrey, Clerk in Holy Orders the patrons of the rectory of the parish of Kirkheaton aforesaid (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Christ Church Woodhouse, of the said new parish of Saint John the Evangelist Bay Hall, and of the parish of Kirkheaton aforesaid which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Thomas Bradley situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Thomas Bradley.
