Panay—Intended Group-flashing Light on Sibuluak Babai.

THE Spanish Government has given notice that, on 15th August, 1895, a light will be exhibited from a lighthouse recently erected on the northern point of Sibuluak Babai, the northern of the Gigantes Islands, north-east coast of Panay :-

Sibuluak Babai Light will be a fourth order catadioptric, group flashing white and red light, with visible from N. 75° E., through east and south, to N. 17° W., but will be obscured in that arc from S. 88° W., through west, to N. 84° W. by Uai-dajon Island; the light is elevated 78 feet above the sea, 38 feet above the ground, and visible from a distance of 14 miles in clear weather.

The lighthouse is a cylindrical tower, on a quadrangular base, and has an iron balcony round the upper part, the whole painted light gray. The keeper's dwellings, painted a light colour, are situated at the rear of the lighthouse.
