No. 629.—ENGLAND—EAST COAST. River Tyne Entrance-Alterations in Lights.

INFORMATION has been received through the Trinity House, London, that on 11th November, 1895, the undermentioned alterations would be made in the lights at the entrance of River Tyne:-

1. North Pier Permanent Light will consist of a fourth order, fixed green light; over a sixth order, fixed white light; over a fifth order, fixed red light; the three lights placed vertically 5 feet apart, the white light at an elevation of 63 feet above high water, and all visible 7 miles in clear

The lighthouse is a grey limestone, cylindrical tower, situated on the extremity of North Pier.

Approximate position, lat. 55° 0′ 55" N., long. 1° 24' 5" W.

The temporary lights (green, red, white) at the extremity of North Pier will be discontinued.

2. South Pier Light, a new light, will be a third order, dioptric, occulting light with a period of ten seconds thus :- light, eight seconds; eclipse, two seconds; showing the following sectors:—white, from about W.  $\frac{1}{2}$  N, through west and south, to E.  $\frac{1}{2}$  S. (on the north or Channel side), and red, from about E.  $\frac{1}{2}$  S., through east and north, to W. ½ N. (on the south or shoal side); it will be clevated 49 feet above high water, and visible 7 miles in clear weather.

The lighthouse is a grey limestone, cylindrical tower, situated on the extremity of South Pier.

3. The light (fixed red) on the middle of North Pier will be discontinued.

4. The leading lights (two fixed white) at North Shields will be shown from the undermentioned positions :-
