THE Queen has been pleased to direct Letters
Patent to be passed under the Great Scal
of the United Kingdom of Great Britain and
Ireland, for presenting the Reverend Edward
Riley, M.A., to the Vicarage of Preston, in the
county of Sussex and diocese of Chichester, void
by the resignation of the Reverend Allan Davidson
Freeman, the last Incumbent.

THE Queen has been pleased to grant unto John Launcelot Errington, Clerk in Holy Orders, Vicar of Midgham, near Reading, in the county of Berks. Master of Arts of the University of Oxford, and to Frances Isabella Turbutt Errington, his wife, the elder daughter of Henry John Goodwin, late of Hinckley Wood, near Ashhourne, in the county of Derby, Clerk in Holy Orders, by Frances Eleanora, his wife, daughter of Richard Burrow Turbutt, late of Morton, in the said county of Derby, Clerk in Holy Orders, all deceased, Her Royal licence and authority that they may, in compliance with a proviso contained in the last will and testament of the said Richard Burrow Turbutt, take and bear the surname of Turbutt only in lieu and in substitution of that of Errington, that he the said John Launcelot Errington may bear the arms of Turbutt, and that the said surname and arms may in like manner be taken, borne, and used by the issue of their marriage; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms. otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her-Majesty's said College of Arms.
