provided with clean bills of health, must convey them to Mogador Island direct as they will not be permitted to land them at any other place in Morocco until the pilgrims have been disinfected on the Island. Vessels with clean bills of health and good health on board, carrying not more than 25 Hadjis, will be permitted to land them at Tangier after disinfection and fumigation of themselves and baggage.
